

An Ordinance to Amend Subsection 9.15(2)(a), to Repeal Subsection 9.15(2)(b)7, and to Renumber 9.15(2)(b)8 to 9.15(2)(b)7 of the West Allis Revised Municipal Code Relating to Licenses and Fees for Charitable Organizations Engaged in Pawn Shops, Secondhand Stores and Secondhand Jewelry Dealers.

The Common Council of the City of West Allis do ordain as follows:

PART I. Subsection 9.15(2)(a) of the Revised Municipal Code of the City of West Allis is hereby amended to read:

9.15 PAWN SHOPS, SECONDHAND STORES, SECONDHAND JEWELRY DEALERS.

\* \* \*

(2) License Required.

(a) No person shall operate any pawn shop, secondhand or junk store, or deal in secondhand precious metals, gems or jewelry in the City of West Allis without first having obtained a license from the City of West Allis therefore. No license fee shall be charged to a charitable organization registered pursuant to Sec. 440.42, Wis. Stat.

\* \* \*

PART II. Subsection 9.15(2)(b)7 of the Revised Municipal Code of the City of West Allis is hereby repealed.


PART III. Subsection 9.15(2)(b)8 of the Revised Municipal Code of the City of West Allis is hereby renumbered to 9.15(2)(b)7.

PART IV. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby amended.

PART V. This ordinance shall take effect and be in force from and after its passage and publication.


