On 06/05/10 a 17 year old named Christopher CA Cesar, m/w, 02/07/93, assisted me with tobacco sales compliance checks at various businesses in the City of West Allis. I drove him to various West Allis businesses and he went inside to attempt to purchase a tobacco product.

**TOBACCO SALES VIOLATIONS**

Christopher was sold a pack of Newport cigarettes at the following businesses: Walgreens at 10725 W. Greenfield Ave, Weis Petroleum at 12004 W. Greenfield Ave and CVS at 9220 W. Greenfield Ave.

During a check at Walgreens at 10725 W. Greenfield Ave Christopher returned to the car with a pack of Newport cigarettes. We went in the business and he identified Sarah M. McCorkle as the person that sold to him. Sarah was issued municipal citation M97566 selling tobacco product to an underage person. On 06/05/10 via phone I spoke with Sarah McCorkle's father, Corbitt B. McCorkle.

During a check at Weis Petroleum at 12004 W. Greenfield Ave Christopher returned to the car with a pack of Newport cigarettes. We went in the business and he identified Philip M. Weis as the person that sold to him. Philip was issued municipal citation M96330 for selling tobacco product to an underage person.

During a check at CVS at 9220 W. Greenfield Ave Christopher returned to the car with a pack of Newport cigarettes. We went in the business and he identified Ashley K. Bornhofer as the person that sold to him. Ashley verbally identified herself and was issued municipal citation M-96321 for selling tobacco product to an underage person.

**ADDITIONAL VIOLATION**

During a check at Express Pantry at 8530 W. Greenfield Ave Christopher returned to the car with a pack of cigarettes. Note: I learned that this business was already checked twice this year consequently no citations were issued for this violation.
