WHEREAS, The Purchasing/Central Services Division has reported that it has received a proposal for three (3) Segway Personal Transporters (PT) for the Police Department of the City of West Allis; and,

WHEREAS, The Common Council deems it to be in the best interests of the City of West Allis that the proposal of Segway of Wisconsin be accepted; and,

WHEREAS, the Police Department has determined that this contract is inappropriate for competitive selection because of the postive impact it will have on their budget and the environment.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the proposal dated May 28, 2010 submitted by Segway of Wisconsin for three (3) Segway PTi2 with accessories for the total estimated sum of \$17,000 be and is hereby accepted.

BE IT FURTHER RESOLVED, that the Purchasing/Central Services Division be and is hereby authorized to enter into a contract for the aforesaid equipment.

Dear Commissioners:

The newest tool that we believe would enhance our community policing activities is the addition of Segway Personal Transporters (PT). The Segway Company has been around for a while, but PT's have not yet been implemented by Law Enforcement agencies in Southeastern Wisconsin. In fact, we may be the first municipal Law Enforcement agency in Wisconsin implementing Segways.

Simply, we believe that it will truly increase public interaction with the police in a positive way. Not only is the Segway PT a wonderful device for community interactions, its uses for normal patrol functions is unlimited. The PT could be utilized for beat patrol in the downtown area, and in any of our parks, parades, schools or community events. Its silent running qualities would be very beneficial to the evening and nightshift officers to silently work their way through alleys in search of criminal activity. The Segway PT can take you places that a car or bicycle can't including inside many stores, office buildings, businesses & elevators.

In addition, implementation of this PT will have a positive impact on our budget and environment. The overall fuel savings on an annual basis could be approximated at \$6,000 to \$10,000 in fuel savings.

The cost of the three Segways and accessories is approximately \$17,000.00. A copy of the proposal has been attached. The funding for this purchase will be taken from grant funding supplied by the U.S. Department of Energy - (EECBG) grant. Approval by the Common Council will be required for this purchase.

*NOTE*: We will deliver your machines to your Department complementary (our normal charge is \$.50 per trip mile from New Lisbon). Our trainer rate for you will be \$200.00 per day (normal rate is \$250.00 per day plus travel). We can train up to 15 riders per day depending on certain variables.

## Additional Options for your consideration

The specific Patroller Models are a "Sole Source" (bid through Segway, Inc.) government procured machine. The i2 Patroller would be approximately \$6925.00 from them. Our set-up and delivery would be approximately \$350.00. The primary difference in the i2 Patroller and the i2 I presented is the LeanSteer which is configured differently to accommodate the carrying case, lighting and specific Police identification
