The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of July.

**Incident reports:**

**Case #16-21460, 06/03/2016, 0157 hrs: 9033 W. National Av – JBeans (Late reporting)**

On 06/03/2016, Officers responded to JBeans for an assault. Investigation revealed a male party was punched in the face one time by an unknown male while inside the bar. He suffered a laceration above his left eyebrow and refused medical treatment. The unknown Offender fled before Officers arrival. The bar manager was unable to burn a copy of the surveillance footage. (Please note: This bar has been uncooperative in past investigations by not providing requested evidence.)

**Case #16-26871, 07/04/2016, 0231 hrs: 903 S. 84 St – Town Beer & Liquor**

On 07/04/2016, Officers responded to the Town Beer & Liquor to meet with a party who claimed she was assaulted by a male known as "Paco" inside of Town Beer & Liquor. She was highly intoxicated and was unsure of the time of the assault, but remembers it being the night before. She claimed that Paco knocked her visor and glasses off and struck the side of her head. The bar owner, Prachi Patel advised "Paco" accidentally knocked her visor off and the two drank together for the rest of the night. No arrest was made.

**Case #16-27348, 07/07/2016, 2347 hrs: 6404 W. National Av – TNT Sports Bar**

On 07/07/2016, Officers responded to 1557 S 64 St for a report of a male outside with a firearm. Officers made contact with the male who was highly intoxicated at TNT Sports Bar. He was

ordered, at gunpoint, to get on the ground and place his hands behind his back. He complied and admitted to walking around the front of his residence holding a black BB gun. He was arrested for DC while armed, cited and released. The male party's BAC was .11 g/210L.

**Case #16-27364, 07/08/2016, 0208 hrs: 6404 W. National Av – TNT Sports Bar**

On 07/08/2016, Officers observed someone flagging them down. Investigation revealed that there was an unruly customer inside TNT Sports Bar and she was thrown out of the bar because of her actions. The bartender confirmed the woman was drunk and bothering some of the patrons. A fight started and he just wanted to her out of the bar. In the process of this, he did have to restrain her on the pool table. She was kicking and hitting him while he was restrained. No arrests were made.

**Case #16-27623, 07/09/2016, 1819 hrs: 11904 W. Greenfield Av – Brass Monkey**

On 07/09/2016, Officers responded to Brass Monkey for a minor crash in the parking lot. The driver of the striking vehicle was intoxicated and blew a .193 on the PBT. He was arrested/cited for OWI first offense and released. The driver had been drinking alcohol inside Brass Monkey prior to the accident.

**Case #16-27698, 07/10/2016, 0142 hrs: 9442 W. National Av - Heartbreakers**

On 07/10/2016, Officers responded to Heartbreakers for a disorderly conduct call. Investigation showed a male party had a physical altercation with a female party outside of the business. Prior to leaving the scene, the male party threatened multiple witnesses that he was going to return with a firearm and shoot everyone. Officers were unable to locate the male party, however he was mailed a municipal citation for Disorderly Conduct.

**Case #16-28304, 07/14/2016, 0056 hrs: 6540 W. Grant St – Alibi Bar**

On 07/14/2016, Officers responded to The Alibi Bar regarding two disorderly subjects. Investigation revealed a male and a female party spilled beer on the bartender and refused to leave the establishment. The male party threw a bar stool and bicycle across the bar and the female grabbed the bartender's face, causing injury to his left eye. The two Offenders were arrested for Disorderly Conduct, issued municipal citations and released.

**Tobacco and Alcohol Compliance checks:**

Case #16-24475

A Tobacco Compliance Check was conducted at 14 randomly selected West Allis businesses that have a license to sell tobacco. The check was completed through the use of a 17 year old female who attempted to purchase a pack of Newport cigarettes. All of the businesses that sold tobacco requested the female present identification and ultimately declined the sale in accordance to the law.
