AGREEMENT

This **AGREEMENT** is made and effective as of the date signed below; by and amongst the City of West Allis, hereinafter referred to as "City," and "Dilneet Corporation d/b/a West Allis Liquor & Tobacco" by Rupinder Randhawa, hereinafter referred to as "Randhawa."

WHEREAS, on January 1, 2010, the City assessed and levied a 2010 real estate tax pursuant to Chapters 70 and 74 of the Wisconsin Statutes against Randhawa in the amount of Seven Thousand Seven Hundred Three and 54/100 Dollars (\$7,703.54); and,

WHEREAS, on January 1, 2010, the City assessed and levied a 2010 personal property tax pursuant to Chapter 74 of the Wisconsin Statutes against Randhawa in the amount of Six Hundred Sixteen and 26/100 Dollars (\$616.26); and,

WHEREAS, interest of 1.5% per month accrues on the unpaid principal amount of the real estate tax and personal property tax;

WHEREAS, Randhawa attempted payment of the taxes, but the checks bounced and cost the City \$50 in non-sufficient fund fees;

WHEREAS, Randhawa is delinquent in paying said personal property taxes and real estate taxes in full, as of September 27, 2011; and,

WHEREAS, the City Clerk's Department withheld the issuance of a 2011-2012 Class A liquor license, tobacco license, and food sales license to Randhawa until she had paid said delinquent real estate and personal property taxes in full; and

WHEREAS, Randhawa seeks to obtain a 2011-2012 Class A liquor license, tobacco license, and food sale license for West Allis Liquor & Tobacco as soon as possible so as to not interrupt its business operations for the current year;

NOW, THEREFORE, based upon the foregoing, the City and Randhawa agree to the following:

Randhawa agrees to pay the 2010 delinquent real estate and personal property taxes, hereinafter referred to as "taxes," and non-sufficient fund fees on the following terms:

- Randhawa will pay Five Hundred and 00/100 Dollars to the City of West Allis on or before October 3, 2011 for the delinquent taxes. The check should be made <u>payable</u> to the City of West Allis and directed to Assistant City Attorney Jenna Merten at City Hall. The City will send the payments on Randhawa's behalf to the Milwaukee County treasurer when applicable.
- 2. Randhawa will pay at a rate of \$500.00 by the first of each month (November 2011 onward) until the balance of the taxes principal and interest and non-sufficient fund fees are paid in full.

In the event that Randhawa fails to adhere to the terms of this **AGREEMENT**, the City reserves its right to immediately revoke any and all liquor, tobacco, and food sales licenses granted to Randhawa without further notice, at which point Randhawa would no longer be able to legally operate her business within the City of West Allis. In the event that the City takes action to revoke any licenses, Randhawa maintains her right to appeal said revocation to the License and Health Committee of the City of West Allis.
