

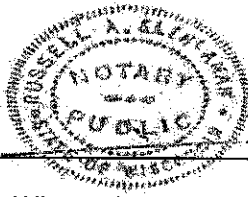


NOTICE OF HEARING

The Common Council of the City of West Allis will hold a public hearing on September 15, 2020, at 7p.m., or as soon thereafter as the matter may be heard, in the Common Council Chambers of the City Hall, 7525 W. Greenfield Ave., West Allis, WI, upon a Resolution herein described and will act upon said resolution as said time and place.

The City is considering to vacate and discontinue a portion of public alley way between S. 71 and S. 70 St. north of W. National Ave, as requested by Max Meinerz, of GG 003 LLC. A resolution (R-2020-0441) introducing said request was presented to the Common Council of the City of West Allis on August 4, 2020.

The subject area is shown and identified as a map exhibit A of the City of West Allis Development Department dated July 22, 2020, which is attached and incorporated within this notice.

Prior to the public hearing on September 15, 2020, State Statutes requires publishing a class 3 notice and personal service on abutting landowners at least 30 days before a public hearing or, if they can't be personally served, the notice needs to be mailed to them at least 30 days ahead of time.

Any abutting owner can object to discontinuance by filing a written objection; it would then take a 2/3 vote by the council to override that objection. Should the Council decide to vacate this portion of unimproved public right-of-way, the abutting property owners would receive an abutting portion of land.

If you have any questions or concerns regarding this notice, you may attend the public hearing.

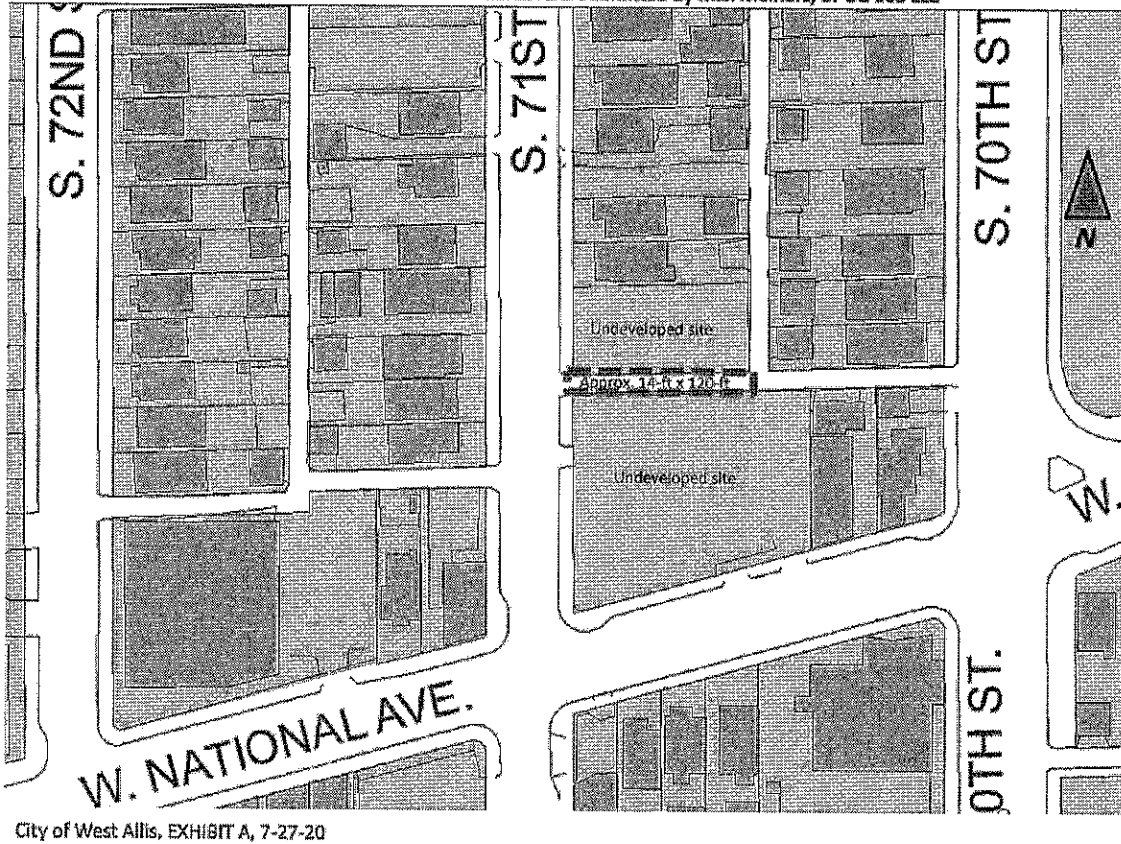
