**RESOLUTION TO AMEND CERTAIN ACTIVITIES OF THE FY 2022 ANNUAL
ACTION PLAN OF THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)
PROGRAM RELATIVE TO REALLOCATING FUNDING IN THE AMOUNT OF
\$50,000.00 TO IMPROVE THE LIBERTY HEIGHTS PARK PAVILION**

WHEREAS, the Common Council of the City of West Allis has approved the FY2022 Community Development Block Grant (CDBG) Annual Action Plan under Resolution R-2021-0665; and,

WHEREAS, reallocation of prior year's unspent housing rehabilitation funds to a public facility activity requires a public hearing; and,

WHEREAS, the utilization of CDBG funds for the Liberty Height Park Pavilion meets HUD requirements for the CDBG program. HUD regulations require funds to be allocated to programs and activities meeting national objectives of the CDBG Program, such as assisting with the needs of low-to-moderate income people. The demolition and construction of a new pavilion will enhance and provide an accessible facility for community activities; and,

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that it hereby reallocates \$50,000.00 of prior years' unspent multi-family housing rehabilitation funds to a public facility activity at Liberty Heights Park Pavilion, within the FY 2023 Community Development Block Grant Annual Plan, toward the completion of the park pavilion activity (EXHIBIT A).

NOW THEREFORE, BE IT FURTHER RESOLVED, by the Common Council of the City of West Allis as follows: That additional \$50,000.00 be and is hereby appropriated from the FY 2022 Community Development Block Grant (CDBG) Program Annual Action Plan to FY 2023 public facilities activity Liberty Heights Park Pavilion.
