The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of September.

Incident reports:

Case #16-36337, 09/02/2016, 1750 hrs: 5732 W Mitchell St - Uncle Fester's

On 09/02/2016, Officers responded to an assault at Uncle Fester's. Investigation revealed a female party pulled the hair of another female and punched her in the back of the head during an argument over the victim owing someone money at the bar. The Offender left prior to Officers arrival and was not identified. The victim had no physical injuries.

Case #16-36417, 09/03/2016, 0242 hrs: 1309 S 60 St - Remedy

On 09/03/2016, Officers responded to a physical altercation at Remedy Bar. Two females had an argument which turned physical. One female struck the other on top of the head with a glass bottle, causing minor injuries. The Offender was highly intoxicated, and could hardly speak or form complete sentences. The Offender was booked out of custody for battery. The victim was taken to St Luke's Hospital to receive medical treatment for her injuries.

Case #16-39921, 09/24/2016, 0047 hrs: 9442 W. National Av - Heartbreakers

On 09/24/2016, Officers responded to Heartbreakers for a report a physical fight. Security removed a highly intoxicated party form the tavern. The party was uncooperative throughout the investigation and was arrested, printed and booked for Consumption of Alcohol by a Person 17-20 years of age. Security denied he was inside the tavern.

Case #16-40333, 09/26/2016, 2048 hrs: 9442 W. National Av - Heartbreakers

On 09/26/2016, Officers responded to Heartbreakers for a report of a Fraud on Restaurant. The offender purchased \$156.00 in alcohol and \$180.00 in lap dances. He was unable to pay for the alcohol he consumed. He was booked out of custody for Fraud on a Restaurant. He was issued a citation and advised he is no longer welcomed at the business.

Case #16-40838, 09/30/2016, 0115: 9442 W. National Av - Heartbreakers

Officers observed two vehicles traveling in tandem in and followed them to Heartbreakers where they conducted a drug transaction. The buyer stated he was instructed by the seller to follow him to Heartbreakers. The seller exited his vehicle and went inside Heartbreakers. When he came out, he handed him crack cocaine. The buyer was arrested for Possession of Cocaine and the seller was arrested for Delivery of Cocaine.

Call #16-40943, 09/30/2016, 1813 hrs: 6500 W. Greenfield Av - 6500 Bar

On 09/30/2016, Officers responded to the 6500 Bar for a report of a noise complaint. Upon arrival, officers heard music coming from the tavern from approximately a half block away and several of the side windows were open on the building. All proper licensing was available and presented upon request. The manager closed all the windows and lowered the music.

Case #16-40843, 09/30/2016, 0157 hrs: 11904 W Greenfield Av – Brass Monkey

On 09/30/2016, Officers responded to a possible intoxicated driver that left Brass Monkey. The Officer located the party and he was arrested for $OWI - 2^{nd}$ Offense. His breath sample was .14 g/210L. He stated he consumed quite of few beers at Brass Monkey.

Tobacco and Alcohol Compliance checks:

Case 16-38989

On 09/18/2016, Officers conducted a Tobacco Compliance Check at 13 randomly selected West Allis businesses that have a license to sell tobacco. The check was completed through the use of a 17 year old female who attempted to purchase of nicotine products. Out of the 13 businesses, 2 businesses completed the sale to the 17 year old without identification. One business allowed the sale of a pack of cigarettes and one business allowed the sale of E-smoking device paraphernalia. The employees were both issued municipal citations

On 09/20/2016, Officers conducted an Alcohol Compliance Check at 12 randomly selected businesses that sell alcohol. The check was completed through the use of a 20 year old female who attempted to purchase a six pack of Miller Lite beer. Out of the 12 businesses, 10 asked for identification and declined the sale to the minor. The employees who completed the sale were issued municipal citations for Selling an Alcoholic Beverage to an Underage Person. The owners for the business were also mailed citations.

On 09/27/2016, Officers conducted an Alcohol Compliance Check at 11 randomly selected businesses that sell alcohol. The check was completed through the use of a 20 year old female who attempted to purchase various alcohol products. All 11 businesses required an Id to complete the purchase.
