**RESOLUTION TO APPROVE BID OF UPI CONSTRUCTION LLC FOR STREET
CONSTRUCTION IN S. 59TH ST. FROM W. MOBILE ST. TO W. BELOIT RD. AND
S. 61ST ST. FROM W. NATIONAL AVE. TO W. MINERAL ST. IN THE AMOUNT OF
\$2,677,944.25**

WHEREAS, The Board of Public Works reports that it duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as hereinafter described; that the bids received as shown on the attached bid report were reasonable and hereby recommends and deems it to be for the best interests of the City of West Allis that the bid of UPI Construction LLC for 2023 Project No. 1 be accepted.

NOW THEREFORE, BE IT RESOLVED By the Common Council of the City of West Allis that the bid of UPI Construction LLC. for 2023 Project No. 1 for installation of concrete curb and gutter, concrete pavement, concrete sidewalk, driveway replacement, sanitary sewer relay, storm sewer installation and relay, water main relay, building services and utility adjustments in:

S. 59th St from W. Mobile St. to W. Beloit Rd.
S. 61st St. from W. National Ave. to W. Mineral St.

(PLAN FILE NOS. SP-1281, SP-1282, S-1670, S-1672, S-1673, W-1442, W-1443, W-1445, W-1446, U-2685, U-2686, U-2687, U-2688, X-932)

for the sum of Two Million, Six Hundred Seventy-Seven Thousand, Nine Hundred Forty-Four and 25/100 dollars (\$2,677,944.25) be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED That said improvements be installed with funding by Bond Funds, Water Utility Funds, Sanitary Sewer Funds, Storm Water Management Funds and Special Assessments.
