

**CITY OF WEST ALLIS
RESOLUTION R-2024-0535**

**RESOLUTION REQUESTING A PERMANENT EASEMENT FROM THE
WISCONSIN DEPARTMENT OF NATURAL RESOURCES TO THE CITY OF
WEST ALLIS FOR STORM SEWER FACILITIES**

WHEREAS, the City of West Allis ("City") inherited storm sewer facilities from the former Allis-Chalmers Organization which were installed under what is now known as the Department of Natural Resources (WDNR) Hank Aaron State Trail; and

WHEREAS, these storm sewer facilities from the former Allis-Chalmers Organization were installed without an easement; and

WHEREAS, these storm sewer facilities from the former Allis-Chalmers Organization are in need of repair; and

WHEREAS, the WDNR requires an easement for the storm sewer facilities prior to the City being able to repair said storm sewer facilities; and

WHEREAS, the City has prepared an easement document for a Permanent Easement ("Easement"), a copy of which is attached hereto and incorporated herein by reference, on the property located in the City of Milwaukee and legally described in Exhibit "Storm Sewer Easement Exhibit" of the Easement; and,

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis as follows:

1. That the Permanent Easement between the City of West Allis and Wisconsin Department of Natural Resources, which is attached hereto and incorporate herein by reference, be and the same is hereby approved to be sent to the Wisconsin Department of Natural Resources.
2. That the Mayor and the City Administrative Officer be and are hereby authorized and directed to execute the attached Permanent Easement on behalf of the City of West Allis once approved by the Wisconsin Department of Natural Resources.
