An Ordinance to Amend Subsections 9.15(3)(d), (7)(c)(1) & (7)(d)(1)(b) & (d) of the West Allis Revised Municipal Code Relating to Pawn Shops, Secondhand Stores, & Secondhand Jewelry Dealers.

The Common Council of the City of West Allis do ordain as follows:

PART I. Subsections 9.15(3)(d), (7)(c)(1) & (7)(d)(1)(b) & (d) of the Revised Municipal Code of the City of West Allis are hereby amended to read:

9.15 PAWN SHOPS, SECONDHAND STORES, SECONDHAND JEWELRY DEALERS.

(d) "Secondhand Article or Junk Dealer" is defined as any person, other than an auctioneer, who engages in the business of purchasing or selling secondhand articles as defined above, who is not either a "pawnbroker" or a "secondhand jewelry dealer" as defined above.

- (c) Electronic Reporting.
- 1. Any dealer or pawnbroker who conducts 200 or more transactions per year shall electronically report each article purchased or received after April 1, 2010 using a computer program approved by the West Allis Police Department. Such report shall occur no more than 24 hours after the article is purchased or received and shall contain a complete description as required in Subsection (7)(b)(2) and a clear, unaltered digital photograph of any jewelry or article without a serial or identification

b. Subsection (7)(d)(1)(a) does not apply if the secondhand article or secondhand jewelry transaction is submitted to the police electronically as described in subsection (7)(c) (1). Any secondhand article or secondhand jewelry purchased or received by a pawnbroker, secondhand article dealer, or secondhand jewelry dealer that is submitted to the police electronically as described in subsection (7)(c)(1) shall be kept on the pawnbroker's, secondhand article dealer's or secondhand jewelry dealer's premises or other place for safekeeping for not less than 15 days after the date the report is electronically submitted. Any secondhand article or secondhand jewelry shall be held separate and apart from any other transaction and shall not be changed or altered in any manner. The dealer shall permit the Chief of Police or any other police officer designated by the Chief to inspect the article or jewelry during the holding period within one business day of an officer's request.

#### Dear Licensee:

On January 5, 2010, the Common Council passed Ordinance number 0-2010-0004 to amend Subsections 9.15(3)(d), (7)(c), (7)(d)(1)(b) & (d) of the Revised Municipal Code concerning pawn shops, secondhand stores, and secondhand jewelry dealers.

I have enclosed a copy of the amended ordinance for your review. Please review the changes to the ordinance carefully. To summarize the changes:

- After April 1, 2010, any dealer or pawnbroker who conducts more than 200 transactions per year shall electronically report each article purchased or received within 24 hours using a computer program approved by the West Allis Police Department.
- A clear, unaltered digital photograph of any jewelry or article without a serial or identification number shall be submitted electronically to the West Allis Police Department.
- All articles reported electronically to the police department need only be held for 15 days on the dealer's premises.
- Consigned articles are exempt from holding periods.

**NEWLY ENACTED ORDINANCE** Please take notice that the City of West Allis enacted Ordinance No. O-2010-0004, an Ordinance Amend Subsections 9.15(3)(d), (7)(c)(1)(7)(d)(1)(b) & (d) of the West Allis Revised Municipal Code Relating to Pawn Shops, Secondhand Stores, & Secondhand Jewelry Dealers.on January 8, 2010. elry Dealers.on January 8, 2010. The ordinance eliminates the word "primary" from the definition of "secondhand article or junk dealer," requires electronic reporting from any dealer or pawnbroker who conducts 200 or more transactions per year, lowers the holding period to 15 lowers the holding period to 15 days for items that are reported electronically, and clarifies that items on consignment are not subject to holding times.
