**RESOLUTION AUTHORIZING THE PURCHASE OF INFORMATION
TECHNOLOGY EQUIPMENT AND SUPPLIES FOR THE NEW PUBLIC WORKS
FACILITY LOCATED AT 1906 S. 53RD ST., IN AN AMOUNT NOT TO EXCEED
\$225,000**

WHEREAS, the City of West Allis is completing construction of a new Public Works facility at 1906 S. 53rd St.; and

WHEREAS, the new facility needs information technology equipment and supplies to support its operations; and

WHEREAS, the Information Technology Department has identified the network infrastructure, peripherals, components, and supplies necessary to outfit the new facility; and

WHEREAS, competitive quotes have been solicited, with a recommended total cost not to exceed \$225,000; and

WHEREAS, the purchase has been reviewed and is recommended by the Director of Information Technology;

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the purchase of information technology equipment and supplies for the new Public Works facility, at a cost not to exceed \$225,000, is authorized and approved.

BE IT FURTHER RESOLVED that funds for this purchase shall be paid from capital funds budgeted for the New Public Works facility.

BE IT FURTHER RESOLVED that the Director of Information Technology, or their designee, is authorized to execute the purchase and any related documents necessary to carry out the intent of this resolution.

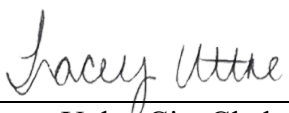

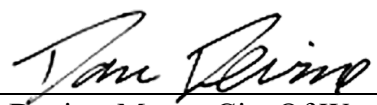
