RESOLUTION RELATIVE TO ACCEPTING THE PROPOSALS OF LANGE ENTERPRISES, AND TAPCO FOR FURNISHING AND DELIVERING 1,000 STATE FAIR NO PARKING SIGNS, SIGNPOSTS, AND MOUNTING ACCESSORIES FOR A TOTAL SUM OF \$71,505.00

WHEREAS, The Purchasing Division has reported that it has received proposals through a competitive bid process for furnishing and delivering aluminum no parking signs, signposts, in-ground mounting wedges, and post clamps for the Public Works Department of the City of West Allis, and that the proposal was reasonable; and,

WHEREAS, The Common Council deems it to be in the best interest of the City of West Allis that the proposal submitted by Lange Enterprises for furnishing aluminum signs, signposts and post mounting clamps for \$43,830.00, and TAPCO for furnishing 750 V-loc and wedge in-ground post mounting sets, for \$27,675.00 be accepted.
