**RESOLUTION TO APPROVE COMMUNITY DEVELOPMENT BLOCK GRANT  
PROGRAM 2023 PUBLIC FACILITY ACTIVITY REMANING FUNDS TO ADD APS  
TECHNOLOGY TO THREE CITY INTERSECTIONS**

**WHEREAS**, the Common Council of the City of West Allis has approved the FY2023 Community Development Block Grant (CDBG) Annual Action Plan under Resolution R-2023-0611; and,

**WHEREAS**, the utilization of CDBG funds for installation of traffic lights and signs activities that meets HUD requirements for the CDBG program; and,

**WHEREAS**, the award of funds must be allocated to programs and activities meeting national objectives of the CDBG Program, such as assisting the needs of low-to-moderate income people and the installation of traffic lights, signs activities and pedestrian improvements; and,

**NOW THEREFORE**, BE IT RESOLVED by the Common Council of the City of West Allis that it hereby allocates the FY 2023 Community Development Block Grant Action Plan relative to allocating \$31,800 of pedestrian improvement public facility activity Downtown Pedestrian Improvement funding, within the FY 2023 Community Development Block Grant Annual Plan, for the installation of three accessible pedestrian signals installed at 92nd and National Ave., 60th and Beloit Rd., and Beloit Rd. and Lincoln Ave. (EXHIBIT A) for the purpose of safety and accessibility as a new activity.


