WHEREAS, the City is considering vacating and discontinuing a Portion of the Street Right-of-Way of West Orchard Street at South 83rd Street.

NOW, THEREFORE, BE IT RESOLVED that the Notice of Hearing, a copy of which is attached hereto, for the vacation and discontinuance of a Portion of the Street Right-of-Way of West Orchard Street at South 83rd Street, be published in the official City newspaper, the NOW, on July 7th, 2011, July 14th 2011 and July 21st, 2011; that the Hearing be scheduled before the Common Council on August 2nd, 2011, at 7:30 p.m., or as soon thereafter as the matter may be heard; that a copy of the aforesaid Notice be served or mailed more than thirty (30) days prior to the Hearing in the manner prescribed by the law on the owners of all of the frontage of the lots and lands abutting upon the said portion of an alley proposed to be vacated and discontinued.

NOTICE OF HEARING

The Common Council of the City of West Allis will hold a Public Hearing on August 2nd, 2011, at 7:00 p.m., or as soon thereafter as the matter may be heard, in the Common Council Chambers of the City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, upon the Resolution herein described and will act upon said Resolution at said time and place. Said Resolution was introduced into the Common Council of the City of West Allis on June 7th, 2011, and proposes the vacation and discontinuance of a portion of the Street Right-of-Way of West Orchard Street at South 83rd Street, legally described as follows:

Public Street adjacent to Lots 1 and 2 in Block 5 and Lots 18 and 19 in Block 1 of the Henderson Park Subdivision and adjacent to Lot 3 in Block 3 of the Assessor's Plat No. 257, both being duly recorded subdivisions of a portion of the Northeast ¼ of Section 4, Township 6 North, Range 21 East, in the City of West Allis, Milwaukee County, State of Wisconsin, more particularly described as follows:

Commencing at the Southeast corner of Lot 18 in Block 1 of the Henderson Park Subdivision; thence West, 15.00 feet along the North right-ofway line of West Orchard Street to the point of curvature and Point of Beginning; thence Southwesterly, 183.59 feet, along a curve to the left with radius of 115.00 feet, a chord of 164.70 feet, which bears South 45°00'00" West, to the West rightof-way line of South 83rd Street and point of tangency; thence North, 115.00 feet along the West right-of-way line of South 83rd Street, to the North right-of-way line of West Orchard Street; thence East, 115.00 feet, along the North right-ofway line of West Orchard Street to the Point of Beginning.
