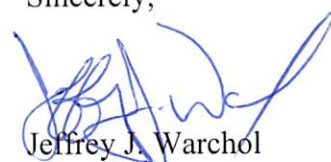
RE: Requesting Approval to Recoup City's Investment in a Damaged City Truck

Dear Mayor and Alderpersons:

The City of West Allis purchased a 2003 freightliner FL70 M2 business class single axle cab and chassis, Serial No. 1FVACXAK83HL06636, which needed some modifications in order to meet the needs of the Public Works Department. The purchase of the truck, including all modifications, was \$40,300.00. The City hired Dealers Choice Truckaway, d/b/a Truckmovers, to transport the vehicle from North Carolina to the City of West Allis. On January 8th, 2008, during transport, an accident occurred whereby the City's truck was damaged beyond repair.

Due to the value of the loss exceeding \$10,000.00, the City Attorney's Office is seeking authority to enter into an agreement and negotiations with Dealers Choice Truckaway, d/b/a Truckmovers, and its insurance company to recoup the City's full investment in the truck of \$40,300.00 plus storage, towing costs and any other property damage that occurred as a result of the accident.
