- I, Charline Hart, being first duly sworn, state as follows:
- 1. I am the owner and registered agent of Bechers Corner Spot, LLC (hereinafter, "Bechers").
- 2. It is my intention, with the approval by the proper city authorities, to sell any and all ownership interest in Bechers, and transfer any all licenses associated with that business, to the extent allowable by law, to Oyweda Renee Watkins.
- 3. I am not related in any way, by blood or marriage, to Ms. Watkins. She was merely an acquaintance of mine prior to our discussions about the sale and purchase of Bechers. When a mutual acquaintance heard that I was interested in selling Bechers, he suggested that I contact Ms. Watkins, because she might be interested in purchasing Bechers. I did so and we have reached an agreement for the sale and purchase of Bechers.

I hereby state, under penalty of perjury, that if the sale of Bechers goes through and the transfer of the appropriate licenses are approved, I will no longer have any ownership interest, managerial role, employee relationship, or any connection whatsoever to the business that Ms. Watkins would establish and run at the location where Bechers is currently located, except for what may be reasonably necessary for me to assist in the transition of the business to Ms. Watkins (e.g., a 1-2 week period). Instead, I will dissolve Bechers Corner Spot, LLC, and no longer operate that business, or any other business, in the City of West Allis.
