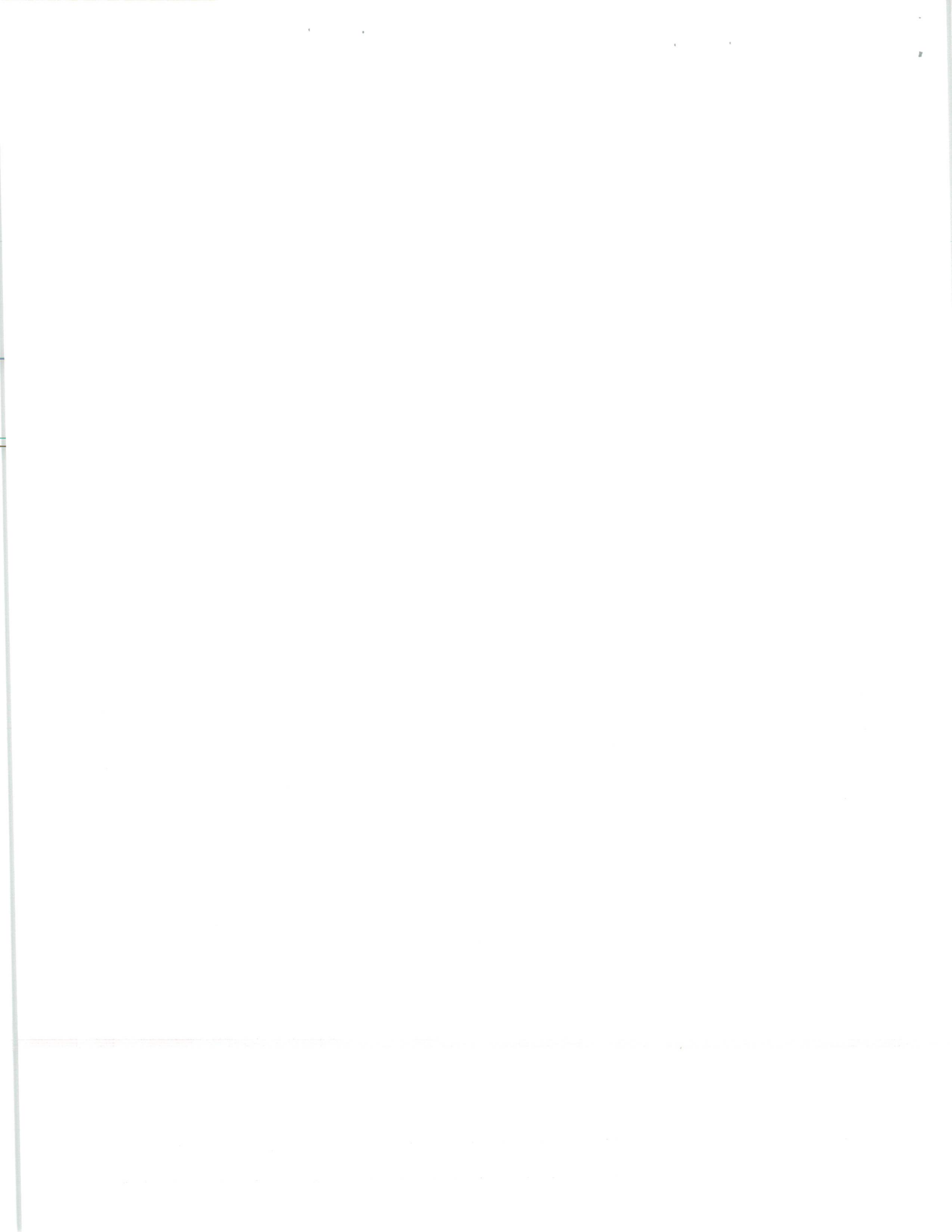

Officers arrested Jahir for Disorderly Conduct Battery.

NARRATIVE

Officer Cato reports...

INITIAL CALL

On 2/4/13 at 0220hrs, officers were dispatched to 1901 S. 60 St Las Palmas Restaurant for a trouble call. The caller reported someone was trying to break into Las Palmas and drove away in a red vehicle. Once on scene, officers observed no signs of forced entry. A few employees were inside the restaurant. Officers spoke with the owner of Las Palmas Antonio C. Rivera m/h, 8/8/76 and customer Daniel Delgado m/h, 7/4/85 about the incident. They informed officers two Hispanic males were involved in the incident. One individual later identified as Jahir Tapia-Gasga m/h 3/2/80 struck the restaurant window several times. Jahir left the area with his friend in a red pick-up truck. I advised responding officers of the information I received from Antonio and Daniel. Officer Said located and traffic stopped the red pick-up truck for our investigation (See DWI13057). I spoke with Daniel and Antonio about the incident.

STATEMENT OF DANIEL DELGADO (VICTIM)

Daniel Delgado had some visible bruises on his face. I asked him if he needed any medical attention and he replied, "No." Daniel informed officers he was involved

in a physical altercation with Jahir Tapia-Gasga. Daniel stated this fight occurred right before bar close. Jahir approached Daniel and said something to him but he could not understand him. Jahir punched Daniel twice in the face, Daniel defended himself by punching Jahir in the face. Daniel explained Jahir punched him in the face with a closed fist 3 times and he did the same to Jahir.

Daniel stated the fight did not last long, because Las Palmas Security stepped in right away to break up the fight. Security told Daniel to stay in the bar as they escorted Jahir out of the restaurant. Jahir and his friend Rodolfo Ramirez left the area on foot. Las Palmas Security was gone.

Daniel explained he knows the owner Antonio Rivera and asked to stay in the bar a little while longer to make sure Jahir had left for good.

Daniel stated a red pick up truck parked on the southside of W. Burnham St next to Las Palmas. Jahir exited the passenger side of the truck. He approached the building yelling and pointing at Daniel. Jahir punched the window several times. The driver of the red pick up truck Rodolfo Ramirez exited the truck and grabbed Jahir pushing him back into the passenger seat of the truck. Jahir returned to the window a second and third time acting in the same manner as before. Rodolfo was able to get Jahir in the truck and they drove away.

Daniel explained he has never met Jahir before. He did not start the initial fight or throw the first punch. Daniel stated he wanted Jahir arrested for the physical altercation.

LACK OF CONSENT

Daniel did not give Jahir permission to punch him in the face.

STATEMENT OF ANTONIO C. RIVERA (OWNER/WITNESS)

Antonio stated he did not witness the actual physical altercation, but he observed Las Palmas Security breaking up the fight between Daniel and Jahir. Security escorted Jahir out of the business. While staff members closed down the restaurant/bar, Antonio allowed Daniel to wait inside to make sure there were not further problems. Sometime after Security left, a red pick up truck parked on the southside of the restaurant. Jahir exited the passenger seat and approached the window. He was yelling and pounding on the window. Antonio thought Jahir may have had a blunt object (such as a rock) and was afraid he might break his window. Rodolfo grabbed Jahir pushing him in the passenger's seat 3 times before he was able to get him to stay in the car. Antonio last observed the red pick up truck traveling southbound on S. 60 St.

Antonio explained he has had security employed for less than a year. He wants to protect his business and prevent it from having problems. This is only the second time he has had an issued. I informed Antonio that he is required to call the West

Allis Police Department anytime Las Palmas Security has to break up a fight. Antonio stated he understood.

BOOKING ROOM

In the West Allis booking room, officers documented Jahir's property. In his brown wallet officers located multiple identification cards, but none of them were of him. There was a fake WI ID card which displays Vincent Martin Torres Jr 5/26/80, a Soc. Sec. Card which displays Vincent Martin Torres Jr. 391-86-9406 and United Community Center membership card for a Vincent M. Torres. He claimed he purchased those items, specifically the Soc. Sec. Card for employment.

A WI DL with picture of Elving M. Torres m/w 5/20/85, which Jahir claims is a cousin.

A Mexico ID Card with picture of Octaviano Tapia-Gasga 3/22/80 which he claims is a cousin.

Jahir was placed on our Fast ID system (3 times) but there was no record of him in the system. I reviewed this incident with Lt. Spath, he suggested I take Jahir's fingerprints and information downtown to Milwaukee Police Department (MPD) Bureau of Identification (B of I).

MIRANDA WARNING

On 2/4/13 at approximately 0428hrs, I interviewed Jahir Tapia-Gasga in Booking interview room A at the West Allis Police Department. I read Jahir his Miranda rights from WAPD Directive 42.016, and he/she stated that he understood his/her rights and would speak to me about this matter without an attorney present. The interview was recorded on an Olympus DS-220 Digital Voice Recorder (Recorder# P17), using audio media card# P17-6. Jahir's statement is paraphrased for this report and is not a verbatim transcript.

Jahir stated he started his night out watching the Super Bowl at Las Palmas around 5pm. Throughout the night he had consumed approximately 8-10 Coronas and 5-6 Tequila shots. Jahir explained before bar close he said good bye to a female bartender. Jahir believed Daniel Delgado became jealous and confronted him. Words were exchanged and Jahir threw the first punch. He apologized for his actions and took blame for starting the fight. Jahir punched Daniel 3 times in the face and Daniel did the same to him. Las Palmas Security seperated them and escorted Jahir out of the business. Jahir stated he left with Rodolfo, but was so upset they returned to the business. Jahir challenged Daniel to come outside to finish the fight. Jahir stated he hit the glass window several times with open hands. Rodolfo tried to get Jahir in the vehicle several times, but he would not listen. They left before officers arrived on scene. Jahir and I spoke briefly about the identification cards he had in his wallet. He acknowledged they were fake and used to gain employment.

NARRATIVE

Officer Gold Reports...

INITIAL RESPONSE

On 02/04/13 at approx. 0220hrs. Officer Pinter and I who were riding together responded to Las Palmas tavern, 1901 S. 60 St. for someone trying to break in or break a window. While enroute to the tavern dispatch further advised a red vehicle is involved. When Officers arrived on scene there was no red vehicle parked outside however Officer Said radioed that he previously observed a red pick up parked outside the tavern just prior to the time of the call.

I entered the tavern and the employees advised that the offenders left S/B on S. 60 St. in a red Dodge Ram pick up with a cap over the bed. I then relayed this information to Officer Said who located the vehicle near 60/Lincoln. It should be noted while inside the tavern I did observe a M/H clutching the back of his head as if he was struck.

Officer Pinter and I then left the tavern and responded to 60/Cleveland where Officer Said had the Dodge pick up pulled over.

CONTACT WITH JAHIR NMI TAPIA GASGA

I made contact with the front passenger in the vehicle, Jahir NMI Tapia Gasga M/H 03/22/80 of 2163 W. Morgan Ave. Milwaukee, WI 53221 (414) 213-5833. The intoxicated Jahir stated he was at the tavern with Rodolfo and they were watching the Super Bowl and drinking. Jahir stated he is friends with some of the employees however another patron began giving him trouble and they exchanged some words. Jahir stated the male party punched him in the face and Jahir punched him back. Jahir did suffer a contusion above his left eye but refused medical attention. Jahir stated they then left the tavern and were pulled over by Officers.

After reviewing Jahir's statement with Officer Cato who was at the tavern, I took Jahir into custody and later turned him over to Officer Cato.
