RESOLUTION R-2024-0488**

**RESOLUTION RECOGNIZING THE CITY CENTER NEIGHBORHOOD
ASSOCIATION, AMENDING EXISTING BOUNDARIES, AND AUTHORIZING AN
ORGANIZATIONAL GRANT UP TO \$1,000**

WHEREAS, the Mayor and Common Council of the City of West Allis, along with its staff and residents, recognize the importance of developing and maintaining healthy neighborhoods throughout the community; and,

WHEREAS, the City Center Neighborhood Association ("CCNA") has been organized by residents and business owners of the City of West Allis to promote and sustain the highest standards in preservation of their neighborhood, and address the issues of safety, social engagement, and neighborhood improvements within its designated boundaries; and,

WHEREAS, the CCNA will serve residents in its area extending from Greenfield Ave. on the north, to the Union Pacific Railroad on the south, and west to 76th Street, and the eastern boundary of 70th Street from Greenfield Avenue to Mitchell and 68th Street from Mitchell to the Union Pacific Railroad, as further described in the attached Boundary Map Exhibit A; and,

WHEREAS, at its meeting on August 15th, 2024, the CCNA adopted the bylaws of the association, and elected a Board of Directors; and,

WHEREAS, R-2015-0215, approved the organizational establishment of East Allis Neighborhood Association and East Allis and City Center, both existing Neighborhood Associations, seek authorization to reestablish defined neighborhood boundaries; and,

WHEREAS, R-2014-0099 establishes a Neighborhood Grant Program to provide small grants to help organize neighborhood associations and to promote neighborhood enhancement projects and the grant application submitted by the CCNA (attached within Exhibit A) meets the criteria of the West Allis Neighborhood Small Grant Program.

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that:

1. The CCNA is fully formed and officially recognized under the neighborhood association guidelines that were adopted with R-2014-0092 (Neighborhood Association Policies and Procedures).
2. The Mayor, Common Council, and staff of the City of West Allis hereby pledge their support and cooperation in addressing the needs of the residents of this neighborhood and the community in general.
3. The rebounding of the neighborhood association areas for both East Allis and CCNA is accepted as illustrated in Map Exhibit A.

4. A one-time organizational grant to the CCNA of up to \$1,000 is approved to cover costs of community engagement and membership building activities, including a community art experience, association and committee meetings, and a neighborhood gathering.

5. The Mayor or his designee is authorized to enter into a grant agreement by and between the City of West Allis and CCNA for the project amount requested of up to \$1,000.

BE IT FURTHER RESOLVED that this resolution shall be in full force and effect from and after its passage and approval.
