The Common Council of the City of West Allis do ordain as follows:

PART I. Pursuant to Section 10.10 of the Revised Municipal Code, the following parking restriction is established:

Street: W. Oklahoma Ave.

Blocks: 11700, 11800, 11900, 12000, 12100 and 12100, from Root River Parkway Dr. to 370 ft E of S. 124 St.

Side: North

Restriction: 1 Hour Parking

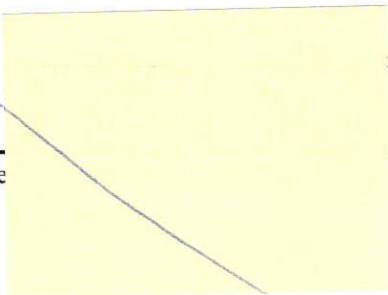
PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.
