Subject: Board of Health reappointments

Mayor,

In reviewing the Council agenda for January 20, there is a communication to the Advisory Committee on Board of Health (2009-0056) reappointing Dr. Bill Greaves. I am requesting that his name be removed and that Dr. Mark Roberts be appointed instead.

A brief overview of medical advisors and board appointments...

Local health departments need medical advisors to annually review and sign standing orders for such things as immunization policies, blood pressure screening policies, etc. Nurses, by limitations in their license to practice nursing, cannot perform these functions independently, but conduct them under the standing orders of a licensed physician. For several decades we had an agreement with the Medical College of Wisconsin for medical advisor services, specifically with Dr. Greaves' Department of Preventive Medicine. There appears to have been something of a fall out between the College and Dr. Greaves and his contract with the College was terminated, and in turn, the College terminated our longstanding agreement for medical advisor services. This left us in somewhat of a lurch and we rather quickly connected with a firm called Exponent and now have the medical advisor services provided by Dr. Mark Roberts, one of Exponent's staff. Dr. Roberts had previously been on the faculty at the Medical College of Wisconsin, in the Department of Preventive Medicine, and for a number of years was the medical advisor assigned to our department. He is very good and we had a very good working relationship with him. It should be noted that we rarely use medical advisor services beyond the annual review and signing of our policies and procedures.

So...how does this exactly relate to a Board of Health appointment???

State statutes governing local Boards of Health requires that a board have a physician, or demonstrate a good faith effort to recruit a physician to the local Board of Health. Over the years it has been very difficult, if not impossible, to recruit a physician who lives in West Allis to serve on the Board. To remedy this, several years ago we changed our local ordinance to create a position on the Board for the current department's medical advisor. It isn't a new tactic, a number of health departments have taken this route to comply with state statutes. Dr. Greaves has been filling that role. We had hoped to make the change to Dr. Roberts during the reappointment time when Dr. Greaves' term expired, which is right now.

This is a rather lengthy explanation, but is quite complete....

Is it possible to amend the communication and appoint Dr. Mark Roberts to the Board? I can provide his contact information if you desire and answer any questions you might have about how we have been working to comply with those Wisconsin statutes.
