

Nature of Accident: Robert H. Litkowski, m/w, 09/16/43 was walking to his vehicle, which was parked in front of Jimmy B's, 7216 W Lincoln Ave. While walking to the vehicle's driver's side, Litkowski stated he slipped on a piece of ice, causing him to fall. Litkowski struck his head / face on the roadway, causing lacerations to his forehead and nose. Litkowski also suffered several abrasions to his head and hand and a bloody nose.

While speaking with the bartender on duty at Jimmy B's, Gregory S Hegedus, m/w, 11/22/69, he reported he served Litkowski 4 standard beers, but did not believe Litkowski was intoxicated.

Street/Walk Condition: I observed the sidewalk in front of 7216 W Lincoln Ave was free from snow and was well salted. I observed the roadway was wet, but I did not observe any ice or snow near Litkowski's vehicle.

Contact with Robert H. Litkowski

Litkowski stated he stepped on / slipped on what he believed to be a piece of ice. Litkowski stated this caused him to fall and strike his head. Litkowski did not recall if he lost consciousness.

Contact with Gregory S. Hegedus (Bartender)

Hegedus stated he had been working at Jimmy B's the entire time that Litkowski was there. Hegedus stated Litkowski only consumed 4 standard beers and that he did not appear intoxicated.

Disposition

Litkowski suffered several lacerations and abrasions to his face and hand and was subsequently transported to AWAMC by WAFD. This report will be forwarded to the C.O. for review.
