The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of November and a couple dates in October.

Incident reports:

Call # 11-046538, 10/29/2011, at approx. 0116 hrs – Johnny Hammers Tavern, 6300 W. Lincoln Ave.

On 10/29/2011, at approx. 0118 hrs, Officers responded to a suspicious activity report at Johnny Hammers Tavern (6300 W. Lincoln Ave). The complainant reported sounds of glass breaking, loud music and men yelling. Officers spoke with several patrons outside the bar; they stated there were no problems. The music in the bar was not loud and no broken glass was found.

Case # 11-009854, 10/30/11, at approx. 0003 hrs - Heros Tavern, 9105 W. Lincoln Ave.

On 10/30/2011, at approx. 0003 hrs, Joshua Johnson (Bar owner of Heros) and Karter Stank (Security for the bar) came into the station to report a former employee assaulted them. Investigation revealed that a former employee struck Mr. Johnson in the face with his hand / fist and also bit Mr. Stank in the chest while Mr. Stank was attempting to remove the disorderly person from the bar. The person responsible for assaulting Mr. Johnson and Mr. Stank also resisted officers' attempts to arrest him. The individual was arrested and cited for Battery and Resisting Officers.

Officers were directed to the suspect who was not in possession of a gun, but was taken into custody for an outstanding WAPD Final Commitment. The bartender reported to officers that the suspect was acting very bizarre, he observed this individual stand up and start stomping his feet. He commented to the bartender that his wife left him, and that he had a gun and would not be afraid to use it. This is when the bartender called the police.

The investigation revealed that several bar patrons were involved in an argument over some knocking on the bathroom door. All parties involved left the bar without further incident.
