**RESOLUTION APPROVING A CERTIFIED SURVEY MAP TO SPLIT AN EXISTING  
PARCEL AT 6021 W. LINCOLN AVE. AND 2307-53 S. 60 ST. INTO TWO PARCELS.

**WHEREAS**, St. Rita's Cong. submitted a Certified Survey Map to split an existing parcel into two lots of record at 6021 W. Lincoln Ave. (Tax Key No. 490-0001-001).; and,

**WHEREAS**, with the grant of this Resolution, the Common Council grants approval to record the map and its documents with the Milwaukee County Register of Deeds Office, subject to Plan Commission review for compliance with zoning ordinance and the 2045 Comprehensive Plan.
