The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of December.

Incident reports:

Case # 11-010970, 12/04/2011, at approx. 0223 hrs – Smokin Joe’s Pub, 6139 W. Beloit Rd.

On 12/04/2011, at approx. 0223 hrs, Officer Mathy was on routine patrol in front of Smokin Joe’s Pub, (6139 W. Beloit Rd) when he observed a M/W subject raise his hands in the air as he drove passed him. Officer Mathy interpreted this gesture as a person who made need police assistance. Officer Mathy was unable to locate the subject in front of Smokin Joe’s Pub, but learned that he went inside the bar. Officer Mathy contacted this person inside the bar; he admitted that he had consumed 5-6 beers while in the tavern earlier.

Officer Mathy discovered that this person was only 20 years of age. This person was subsequently cited for an underage person enter / remain on licensed premises, he was subsequently booked and released.

The two bartenders who were on duty were issued citations for selling/dispensing/giving alcoholic beverage to an underage

Case # 11-011051, 12/07/2011, at 0233 hrs – Wild Bills Saloon, 1454 S 92 St.

On 12/07/2011, at 0235 hrs, officers were dispatched to Wild Bill Saloon regarding an alleged after hours party that was going on inside the bar. Upon officers arrival they observed two patrons inside the bar as well as the bartender who appeared to be intoxicated.

The bartender was issued a citation for remaining open after closing hours. The two patrons in the bar were issued verbal warnings.

Case # 11-011123, 12/09/2011, at approx. 0135 hrs – Night Court Tavern, 7127 W. National Ave.

On 12/09/2011, at approx. 0135 hrs, officers responded to the Night Court Tavern, 7127 W. National Ave., regarding a report of a large fight in the bar (parties allegedly were fighting with bottles). Officers subsequently took 10 subjects into custody. One party was tasered during this altercation. In addition, citations were going to be issued to the bartender for serving two underage patrons.

This was a very volatile incident where several of the arrested subjects struggled with officers during their initial response.

Tobacco and Alcohol Compliance checks:

- No alcohol compliance checks were performed in the month of December.
- No tobacco compliance checks were performed in the month of December.


Violation of Wisconsin Clean Air Act Smoking Ban:

- There was one reported violation for the month of December.

Case # 11-011560, 12/23/2011 at 2213 hrs – Studz Pub, 6833 W. National Ave.

The incident occurred at Studz Pub, (6833 W. National Ave). On 12/23/2011 at approx. 2213 hrs Officers Kwasinski and Ketterhagen conducted a tavern check at Studz Pub and observed a male subject holding a lit cigarette while in the bar. The male offender and the agent of the bar were both cited for this violation of the Clean Air Act (Smoking ban).
