The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of July 2011.

Incident reports:

DEA CASE (Drug Enforcement Agency) – 06/14/2011 at 1038 hrs. Taqueria Buena Vista Restaurant, 6000 W. Burnham St.

On 06/14/2011 at 1038 hrs, officers from WAPD Special Investigations Unit assisted Special Agents from the Drug Enforcement Agency in a buy / bust operation at the Taqueria Buena Vista Bar / Restaurant – 6000 W. Burnham St. During this operation an employee of this business (cook for the restaurant) was arrested while exiting the restaurant. He was arrested on a charge of delivering a kilo of cocaine (31,000 value). He was charged in State Court with Delivery of Cocaine.

The owner of the restaurant and his son, who also works at the restaurant were present and working in the restaurant at the time of this arrest, but were not charged in this case.

The DEA file is attached to this report, but no WAPD report has been generated.

Case # 11-005793, 07/01/2011 at 0107. Larry Michael's Club and Cafe, 8900 W. Greenfield Ave.

On 07/01/2011, at approx. 0107 hrs, officers were investigating a vandalism complaint at Larry Michael's Club and Café (8900 W. Greenfield Ave). As officers were preparing to clear the scene they were advised of a fight inside the bar. Three subjects were subsequently arrested for multiple offenses; including - Disorderly Conduct, Resisting an Officer, CCW and Possession of a Controlled Substance.

Call # 11-027158, 06/30/2011 at approx. 2354 hrs. Jim's Oval Bar, 9141 W. National Ave.

On 06/30/2011, at approximately 2354 hrs, officers responded to a loud noise complaint at Jim's Oval Bar, located at 9141 W. National Ave. Officers had the bartender close the door, which alleviated the problem.

Call # 11-027369, 07/02/2011 at approx. 0237 hrs. Flappers Bar, 7527 W. Becher St.

On 07/02/2011, at approximately 0237 hrs, our department received a phone call reporting 7-8 people were fighting in the street. Due to a high call volume squads were unable to get to this complaint for 33 minutes and once they arrived at the scene everyone was gone.

Call # 11-028346, 07/08/2011, at approx. 0149 hrs. Hero's Tavern – 9105 W. Lincoln Ave.

On 07/08/2011, at approx. 0149 hrs, Officers responded to Hero's Tavern regarding a disorderly conduct complaint. The complaint stems from an allegation that a patron lighted a cigarette in the bar – when this person was asked to extinguish the cigarette and leave the premise, the person who lit the cigarette reportedly went behind the bar and pushed the bartender, separating his shoulder. The offender was located at his residence and gave officers a different version of what occurred; claiming he was pushed first and retaliated by pushing this person back. Neither party wanted medical attention nor wanted to pursue this matter criminally.

Case # 11-006046, 07/08/2011, at approx. 0015 hrs. Dopps Tavern, 1753 S 68 St.

On 07/08/2011, at approx. 0015 hrs, Officers responded to Dopps Tavern regarding a weapons complaint. Officers spoke with the bartender who reported a male party came into the tavern and started an argument with another patron. The party who started the argument raised his shirt at which time the bartender and another patron observed what they believe was a handgun protruding from his back right pocket.

The suspect and another male subject left the bar before officers arrived. A description of the two parties was given to officers, but they were unable to locate the offenders.

Case # 11-006078, 07/09/2011, at approx. 0124 hrs. Ubie's Double Vision, 5501 W. Burnham St.

On 07/09/2011, at approx. 0124 hrs, Officers were dispatched to Ubie's Double Vision for a trouble call (male and female physically fighting). Upon officers arrival they spoke with a female party who reported that an acquaintance of her's robbed her of \$2500.00 while standing outside the tavern. While checking the area for the suspect a male party who was walking in the alley behind the bar (unrelated to this incident) was arrested for resisting an officer (this subject became uncooperative while be questioned by Officer Mees).

The female party who reported being robbed of 2500.00 did not want to pursue charges against the acquaintance that allegedly took her money.

Case # 11-006079, 07/09/2011, at approx. 0235 hrs. Walk Her Inn Tavern, 900 S. 74th St.

On 07/09/2011, at approx. 0235 hrs, officers responded to the intersection of 74 and Walker regarding people fighting in the street. Officers investigation revealed that a male subject who was in the Walk Her Inn bar earlier had become very loud and obnoxious while in the bar. The bartender told this subject to quiet down or leave the bar. This party complied and quieted down. However, after bar close this male subject confronted the female patron who he was playing pool with and the bar owner who told him to quiet down. He began physically assaulting them in the street. The male subject was arrested by officers and charged with 2 counts of Battery.

Case # 11-006101, 07/10/2011, at approx. 0213 hrs. Hero's Tavern – 9105 W. Lincoln Ave.

On 07/10/2011, at 0213 hrs, Officer McNally responded to Hero's Tavern after Officer Gold reported being flagged down by Hero's security. Officers' investigation revealed that a male and female were arguing outside the bar; they were advised to move along by officers, but refused. After several additional requests to quiet down and move along were ignored, both parties were arrested for Disorderly Conduct. The male subject resisted officers and was cited for Resisting an Officer in addition to D/C.

Case # 11-006431, 07/20/2011, at approx. 0326 hrs. Shamrox Tavern, 6851 W. Beloit Rd. (no violation – informational only)

On 07/20/2011, at approx. 0326 hrs, Officers responded to Shamrox Tavern at 6851 W. Beloit Rd regarding a burglary to the business. Five game and the Juke Box were entered and monies taken. The investigation revealed the rear door was forced open. No suspects at this time (ongoing investigation).

Case # 11-006577, 07/24/2011, at approx. 0200 hrs. Hero's Tavern – 9105 W. Lincoln Ave.

On 07/24/2011, at approx. 0200 hrs, Officers were monitoring the area around Hero's Tavern due to previous fights and intoxicated / disorderly subjects.

Officer McNally was subsequently flagged down by Hero's security staff because of a large fight inside the bar. The fight consisted of approx. 15-20 patrons. In the process of breaking up the fight officers took four subjects in custody for disorderly conduct / fighting. One of the arrested parties fought with officers and had the Taser deployed on him. Another arrested party had a valid warrant out for him; and one party was in the U.S. illegally and was turned over to the Bureau of Immigration and Customs Enforcement agency.

Case # 11-006595, 07/24/2011, at approx. 1918 hrs. Hero's Tavern – 9105 W. Lincoln Ave.

On 07/24/2011, at 1918 hrs, Officer Orlowski conducted a tavern check at Hero's Tavern, 9105 W. Lincoln Ave. The officer's check of the person bartending reflected that the bartender license / permit had expired. The bartender indicated that he filed the appropriate paperwork for a renewal, but had not received it. The bartender was advised that he cannot bartend until his license is current.

The owner of the bar was contacted and arrived at the scene shortly after. Two citations were issued, one to the bartender and one to the owner.
