The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of September.

On 09/08/2014, at 1857 hrs, Officers responded to 6300 W. Lincoln Av, Johnny Hammers for a report of an intoxicated driver attempting to leave in his vehicle. The Offender stumbled into Johnny Hammers and the bartender refused to serve him. He then exited the premise. The driver got into a car and struck the parked vehicle in front of him. He was arrested for OWI. A witness at the bar was the caller on this incident.

On 09/18/2014, at 1715 hrs., Officers responded to 6108 W. Burnham St, Fiddler's Green for a male party refusing to leave the bar. The party was harassing the customers and when asked to leave several times, he refused. Officers spoke with him and advised him to leave the tavern. Once outside, he refused to provide Officers with his name. He was arrested for Disorderly Conduct and Obstructing an Officers.

Call # 14-041839, 09/18/2014, at 1715 hrs: 2950 S. 108 St., Buffalo Wild Wings

On 09/18/2014, at 1715 hrs., Officers responded to 2950 S. 108 St, Buffalo Wild Wings for 2 intoxicated male parties refusing to leave the establishment. The parties left before Officers arrival. The manager was spoken to and he stated the waitress served each man five 20oz beers with their meal and then refused to sell them anymore because the men were starting to ask the female wait staff to come over by them and making the wait staff feel uncomfortable. The two

men then went to the bar and each had another 20oz beer because the bartender didn't know the wait staff had already quit serving them. The manager cut them off again. The men became irate at being cut off and one started yelling and swearing at the manager.

Case #14-8319, 09/18/2014, at 1859 hrs: 6426 W. Greenfield Av, Spotlight

On 09/18/2014, at 1859 hrs., Officers responded to 6426 W. Greenfield Av, Spotlight for a 911 call of an assault. Officers made contact with the victim, who is an employee of Spotlight, who stated she was assaulted by an ex-roommate outside the Spotlight. The parties had once resided together and the altercation was over personal property. The Offender was arrested for Battery/Domestic Violence.

On 09/18/2014, at 0058 hrs., Officers responded to 1753 S. 68 St., Dopp's for a report of several intoxicated parties that left the bar and were attempting to kick the door in. Out of the 13 businesses, 11 asked for identification. Two of the businesses, Maas Petro Mart and Speedway (57/Burnham) completed the sale and allowed the 17 yoa to purchase cigarettes without identification.

SUMMARY

Ofc. Primising reports:

On 09-08-14 at 1857hrs, officers responded to Johnny Hammer's, 6300 W. Lincoln Ave, for a report of an intoxicated driver attempting to leave in his vehicle, lic#616MRC. Contact was made with this vehicle and upon activating my emergency lights and exiting my vehicle, the driver turned around in his seat, looked at my squad, and began to pull away. The driver struck the parked vehicle in front of him and officers got him to stop. The driver was identified by DL as Mark M. Arnezeder, M/W 10-23-63. Arnezeder was ultimately arrested for OWI-1st offense, as his last conviction was in 2003. Arnezeder was conveyed to AWAMC for medical attention and admitted overnight. Arnezeder refused to give a Blood Sample. All paperwork was completed on scene and Arnezeder was booked out of custody and ordered in on 09-09-14 for booking.

INITIAL CALL

On 09-08-14 at 1857hrs, officers responded to Johnny Hammer's, 6300 W. Lincoln Ave, for a report of an intoxicated driver attempting to leave in his vehicle described as a green Bonneville, lic#616-MRC. A witness at the bar, Daniel E. Langdon, M/W 11-21-58, was the caller on this incident and advised the vehicle / driver were still on scene, in the 2200blk of S. 63 St.

VEHICLE IN MOTION

Ofc. Stikl and I arrived on scene at the same time and immediately observed the vehicle in question, parked on the east side of S. 63 St., parked just north of W. Lincoln Ave. I pulled up in my fully marked City of West Allis police squad car, directly behind the suspect vehicle and activated my emergency lights. At the time I observed the vehicle, it was clearly running, with one large M/W driver and the reverse lights on. Upon exiting my vehicle, I observed the male driver turn around in his seat and look at my squad car with the emergency lights activated and quickly put his vehicle in drive and accelerate, attempting to drive forward.

The driver did not cut the turn enough to the left and ended up rear ending the parked vehicle in front of him, which belonged to the complainant, Langdon. Officers approached the vehicle, ordering the driver to stop, numerous times. The driver eventually complied and shut off the vehicle, handing the keys to me out of the open window.

At this time through the open window, I asked the driver, later identified as Mark M. Arnezeder, M/W 10-23-63, for his driver's license. Arnezeder ignored my questions and attempted to exit the vehicle numerous times, before complying with my request. Due to Arnedezer initially attempting to flee from the scene, I felt it safest for him to remain in the vehicle until another officer arrived. Each time Arnezeder attempted to open his door, I had to force the door closed, telling him to remain seated in his vehicle. Arnezeder eventually produced a wallet and fumbled through it several times, without finding his driver's license. I asked him for the wallet numerous times, before he handed it to me. I was able to retrieve a WI photo ID card from his wallet, positively identifying him. At this time, I was able to observe an empty plastic bottle of Skol Vodka lying in the center console.

When asked if he had been drinking, Arnezeder initially stated he had not been drinking. I was able to detect a moderate odor of intoxicants emitting from his breath, and that his eyes were very red and glassy. Arnezeder's speech was so heavily slurred, that he was almost impossible to understand. Arnezeder's movements were slow, exaggerated and very lethargic. I again asked Arnezeder how much he had been drinking and he stated, "a few." Arnezeder either ignored any further questions, or answered them inappropriately or made statements completely off topic. Arnezeder denied being injured, ill, or suffering from any medical ailments. Sgt. Pasdera arrived on scene at this time, and Arnezeder was asked to perform SFSTs, to which he agreed.

Upon exiting the vehicle, Arnezeder was clearly unsteady on his feet and had to use his left side to support himself against the vehicle, so he did not lose his balance and fall. To assist Arnezeder to the curb safely, I held on to his right arm and Ofc. Stikl held his left arm. Despite our guidance, Arnezeder nearly tripped on the curb and then walked into a fire hydrant. Once on the curb, I released my grasp on his arm; however, Arnezeder was swaying back and forth, causing Ofc. Stikl to stay close in the event of him losing his balance.

PRE-ARREST SCREENING

Horizontal Gaze Nystagmus

Prior to starting HGN, I faced Arnezeder away from my emergency lights. Arnedezer was not wearing glasses. Arnezeder was asked if he could see my pen and was instructed to touch the tip of my pen. I instructed Arnezeder to follow the tip of my pen with his eyes-only and not to move his head. Arnezeder stated that he understood my directions.

I checked for equal pupil size and equal tracking, a lack of smooth pursuit, distinct sustained nystagmus at maximum deviation and an onset of nystagmus, prior to a 45-degree angle. I checked each eye twice for each clue, starting with the left eye. I also checked for vertical nystagmus.

Results: When asked to touch the tip of my pen, Arnezeder very slowly attempted to touch the pen and ended up stopping approx. two inches before actually touching the pen, realized he had not touched it, then quickly over corrected, eventually touching the middle area of the pen. Arnezeder stated he understood my directions for the test; however, he had to be reminded not to move his head several times and to follow the tip of my pen with his eyes. Throughout the test, Arnezeder was swaying in a circular motion and had difficulty remaining balanced, although he was standing stationary.

I was able to observe lack of smooth pursuit, distinct sustained nystagmus at maximum deviation and an onset of nystagmus prior to a 45-degree angle in both eyes, as well as vertical nystagmus.

Arnezeder exhibited **six** clues or indicators of a possible total of six clues or indicators a person who may be intoxicated by alcohol or drugs may exhibit.

WALK AND TURN

I placed Arnezeder in the instructional stance by having Arnezeder place his left foot on an imaginary straight line with the right foot in front, heel to toe. I told Arnezeder to keep his arms at his side and maintain that position until I told him to begin the test. I gave Arnezeder a complete set of instructions and a demonstration of the test. Arnezeder stated he understood my directions.

Results: Arnezeder could not get himself into the instructional stance, despite officers attempting to assist him numerous times. He therefore was not able to remain in the stance for the duration of the instructions, as he was constantly losing his balance. Arnezeder attempted to start the test too soon on two occasions. The first time, Arnezeder was walking forward with such force that officers had to pull him / push him back, to avoid him walking right into me as I was still demonstrating the test. The second time, Arnezeder started too soon, he stumbled off to the right, causing officers to catch him so he did not fall.

Once he was instructed to begin, Arnezeder took seven steps, missing the heel to toe connection by at least three inches between each step, and stepping off-line on each step. Arnezeder was walking with his feet more side by side than in a straight line, as demonstrated. Throughout the test, Arnezeder raised his arms for balance, so that they were away from his sides by at least six inches. After taking seven steps in the first set of nine steps, Arnezeder stopped walking and looked at me, as if for instructions. I asked Arnezeder if he felt that he had completed the test. Arnezeder stated, "See, I can't do it." I then asked Arnezeder if he wished to complete the test. Arnezeder then performed an improper turn, before stumbling to a stop again. When again asked if he felt he had completed the test, he indicated he had.

Arnezeder exhibited eight clues or indicators of a possible total of eight clues

or indicators a person who may be intoxicated by alcohol or drugs may exhibit.

ONE LEG STAND

I gave Arnezeder a complete set of instructions and a demonstration of the test. Arnezeder stated he understood my directions.

Results: Arnezeder chose to lift his right foot for this test; however, instead of lifting his foot, he placed it out in front of him, fully on the ground, approx. three to four inches in front of his left foot, out to the side. Arnezeder counted to one, before losing his balance. Arnezeder was placed back in the instructional stance and explained the test again, to ensure he understood that his foot needed to be raised off of the ground. Arnezeder stated he understood and attempted the test again. He chose his right foot a second time, but still placed it in the same position on the ground in front of him. On this attempt, Arnezeder counted to two, before losing his balance. Arnezeder had his arms raised throughout the test for balance. For Arnezeder's safety, officers determined it was too unsafe for him to continue to attempt the test, as he was unable to keep his balance.

Arnezeder exhibited three clues or indicators of a possible total of 4 clues or indicators a person who may be intoxicated by alcohol or drugs may exhibit.

ARREST DECISION

Based on Arnezeder's driving behavior, his red and glassy eyes, the odor of intoxicants emitting from his breath, his admission to consuming alcohol, his poor performance on the SFSTs, and my training and experience, it was determined that Arnezeder was operating a motor vehicle while under the influence of an intoxicant.

Arnezeder was handcuffed, searched and conveyed to Aurora West Allis Medical Center, by WAFD MED Unit, for a blood draw.

OTHER OCCUPANTS IN VEHICLE/DISPOSITION

There were no other occupants in the vehicle.

VEHICLE SEARCH

Arnezeder's vehicle was searched incident to arrest. In plain view, the Skol bottle was observed, as well as some prescription medications, and Diabetic testing equipment. The medications were each in bottles with Arnezeder's information on them and appeared to be accurate / accounted for. The medications were as follows: Alprazdam 1mg tab, Quetiapine 50mg, Fluoxetine 40mg, and Combivent Respimat 20mcg/100mcg. In speaking with paramedics, these medications are for Asthma, COPD, Hypertension and Diabetes. All of these conditions were

confirmed with Arnezeder. WAFD responded to check Arnezeder's blood sugar and reported it was within normal range at 96.

VEHICLE & KEYS DISPOSITION

The ignition key for the vehicle remained inside, as N&S Towing took custody of the vehicle incident to Arnezeder's OWI arrest. The remaining keys were turned over to Arnezeder along with the rest of his property.

DWI PROCESS

CITATION ISSUANCE

While at AWAMC, Arnezeder was issued citation #R109862-4 for OWI-1st offense. Arnezeder's last and only prior OWI conviction was 08-13-03, making this a first offense.

INFORMING THE ACCUSED

I read the Informing the Accused for to the defendant and Arnezeder stated that he would not submit to a blood test.

QUESTIONING

While at AWAMC, on 09-08-14 at approximately 2030hrs., I read Arnezeder the Pre-Interrogation Warnings as they are written on the Alcohol/Drug Influence Report form. Arnezeder stated he refused to answer questions, concerning this arrest and did not sign the Alcohol/Drug Influence Report form.

DISORDERLY CONDUCT

While being treated for his breathing condition at AWAMC, Arnezeder was extremely combative with the staff, swearing at them and causing a scene. At several points, Arnezeder needed to be restrained so he did not harm any of the staff. Arnezeder attempted to kick Ofc. Stikl in the face, causing him to be placed in soft restraints. The constant yelling, swearing at officers and hospital staff, and physical struggles that occurred due to Arnezeder's behavior caused a disturbance in the ER and drew the attention of not only other patients, but other hospital staff. Officers had to remain with Arnezeder until he was admitted, due to his disorderly and aggressive behavior.

CASE DISPOSITION

Report was reviewed and approved by Sgt. Pasdera.

STATEMENT OF CALLER- DANIEL E LANGDON

At approximately 1830hrs, Daniel was sitting in the bar Johnny Hammers, 6300 W Lincoln Ave, when he observed Mark Arnezeder drive up in a green sedan, WI LP 616MRC, near the intersection of W Lincoln Ave/S 63 St. Mark turned N/B onto S 63 St and parked behind Daniel's vehicle, 208567, in the 2200blk of S 63 St facing N/B. He explained once Mark placed the vehicle in park, he opened the door and attempted to exit the vehicle.

Mark was unable to exit and sat in his vehicle for approximately ten minutes. During that time, Daniel said Mark was slumped over the wheel passed out. Mark then woke up, exited the vehcile and proceeded across the street to Johnny Hammers. Daniel stated Mark stumbled multiple times when walking towards the bar.

Mark entered the bar and asked to be served alcohol. The bartender refused Mark service because he was already highly intoxicated and asked him to leave. Mark continued to ask for service for approximately ten minutes but was denied each time. Mark became upset and exited the bar.

Daniel explained Mark stumbled multiple times when walking across the street towards his vehicle. Once Mark reached his vehicle, he fumbled his keys and dropped them on the ground. Mark picked up his keys and dropped them again in an attempt to unlock his door. Mark picked his keys up again and entered his vehicle.

Daniel stated he called 911 because he felt Mark was too intoxicated to



STATEMENT OF BRITTANY C. PATTON - VICTIM

Patton said she was assaulted by a known party. She told me the person was an ex-roommate, later identified fully as Lakeitha D. Holt, F/B 05/07/90. Patton told me she was on the steps outside the bar when she observed Holt pull up in her vehicle.

Holt exited the vehicle and asked Patton, "So you not gonna give me my shit back?" Patton told Holt she was not going to give anything back, and Holt should take her to small claims court. I asked her what items she was referring to. Patton said they lived together for approx. three months, and Patton kicked her out, because she stopped paying rent. She said she would give the property back when she received Holt's back rent.

After Patton advised Holt she would not give her property back, Patton asked her why she was there. Holt walked up to her and punched her twice in the face. Someone stepped in between the two, and Patton was able to flee inside the business. Holt followed Patton inside the business, and Patton walked into the changing room where she closed the door on Holt. Patton said the police were called and Holt ultimately left the scene.

Patton was bleeding and had a small abrasion inside her inner lip. She also had a slight swelling by the side of her head. She advised me Holt never said she was arriving, and she did not have any contact with Holt that day.

LACK OF CONSENT

Patton did not give Holt consent to assault her.



Amborn stated the male party was talking "gibberish" to other customers inside the tavern. Williams was telling several of the customers not to smoke or they are going to die.

Amborn stated he put up with Williams comments for about 30 minutes and eventually asked him to leave. Williams refused to leave the tavern and sat down on one of the bar stools. After Amborn asked Williams to leave and he refused, Williams stopped talking and was silent until officers arrived on scene.

CONTACT WITH WILLIAMS

Officer Christianson was already on scene when I arrived and was attempting to speak with Williams inside the tavern regarding the incident. When asked by Officer Christianson, Williams refused to provide his name. Officer Christianson advised Williams did say something to her, but she could not hear him because her police radio was too loud. When asked again for his name, Williams refused to provide it.

I advised Williams to step outside of the tavern so officers could speak with him without disrupting the other customers. Once outside, both Officer Christianson

and I repeatedly asked Williams for his name. Williams refused to provide his name and told Officer Christianson he already gave it to her, which he did not. I asked Williams for his last name, and he told me he did not have one because he was Hebrew.

Williams refused to provide officers with information about the incident and just laughed at officers when we asked him questions.

ARREST OF OFFENDER

Based on Williams behavior inside the tavern, and the fact he refused to provide officers his name, Williams was placed under arrest for disorderly conduct and obstructing. I transported Williams to the station for processing. On the way into the station, Williams threatened to beat me up and repeatedly laughed at me.

BOOKING ROOM

Once at the station, Williams refused to cooperate with officers while he was being searched and had to be held by several officers while I used the Fast ID machine in an attempt to identify him. Williams was placed in a cell while I completed the pre-booking process for him.

After I finished pre-booking Williams, I asked him to exit the cell so I could obtain his photograph and fingerprints. Williams ignored my request and refused to exit the cell. I repeatedly asked Williams to exit the cell, and he refused and would not say anything. Eventually Williams replied, "I know you want me," but still refused to exit the cell.

Williams was left in the cell and was later released from the station, with his municipal citations, during third shift.

CUSTODIAL INTERVIEW

Based on the fact Williams was uncooperative at the tavern and in the booking room at the station, I did not attempt to obtain an in custody statement from him regarding the incident.

INITIAL RESPONSE

On 09/11/14 at about 0910hrs I responded to the intersection of S. 75th St and W. Greenfield Ave for a report of a M/B walking bare foot and into traffic (W.A.P.D Call# 14-40645). W.A.P.D had received two separate calls about this individual (later identified as Tyreese D. Williams) walking into traffic and walking bare foot. Once I arrived in the area I located Tyreese near the intersection of S. 72nd St and W. Greenfield Ave. I exited my marked Police squad and soke with him.

ON-SCENE INTERACTION WITH TYREESE D. WILLIAMS

When I first observed Tyreese I confirmed he was walking barefoot and was only wearing a white t-shirt (it was approximately 50 Degrees F outside) and he appeared to be cold. I explained to Tyreese the reason why I was stopping him and he denied walking into traffic. Tyreese stated he was currently walking home and I offered to give him a ride there. Tyreese initially denied my request to give him a ride home and stated he would walk. I explained to Tyreese how the Police Department had already received three separate calls from citizens who were concerned about his welfare. Tyreese stated he was fine and would continue walking home.

I continued to offer Tyreese I ride home and he started to bring up how his property was not turned over to him when he was released from the West Allis Police Department. I explained to Tyreese I had no knowledge about this because I did not release him. After talking with Tyreese for a bit, I was able to convince him to accept a ride home from me. I placed Tyreese in the back of my Police squad and started transporting him back to his residence. As we reached his residence Tyreese indicated he would be unable to enter his apartment because his keys were not with him. Tyreese indicated his keys were with the rest of his property at the Police station.

I reviewed Officer Schweitzer's supplement report and observed Tyreese had refused to accept his property when released. I asked Tyreese if he would be willing to accept his property if I give him a ride to the Police station and get it for him. Tyreese stated he would be willing to do that, however he would not sign for any of his property.

I subsequently gave Tyreese a courtesy ride back to the Police station and had him wait in the W.A.P.D Booking room, while I got his property. I made Report Dat :

males call her "Katie", was unsteady while attempting to sit on a bar stool. Heim stated she asked "Katie" for identification but later told her she was unable to serve her based upon how intoxicated she was.

Heim stated within a few minutes, she observed the two males had placed two small glasses on the bar. Heim stated the specific glasses they had were not used at their bar and must have come from a separate business. Heim stated the two males began to argue with other patrons inside of the business. While within close proximity of Petersen I detected a strong odor of intoxicants emitting from her breath. Petersen was slurring her speech and had red, glassy eyes.

CONTACT WITH PROBATION/PAROLE

I made contact with Probation/Parole and advised them of the incident regarding Petersen being intoxicated and resisting officers. They advised they would be placing a hold on Petersen.

NARRATIVE

PO Kaye Reports:

On 09/18/14 at approximately 0058hrs, officers responded to Dopp's, 1753 S 68 St, for a report of two males and one female in their mid 20's who were fighting, left the bar, and were attempting to kick the door in. The caller stated one male left the area, and the female (whose name was "Katie") and other male walked southbound on S 68 St. PO Foy went to Dopp's to speak with the caller while I checked the area.

LOCATING ANTONIO K. JOHNSON & KATIE E. PETERSEN

While checking the area I observed a male and female who appeared to be in their mid 20's, later identified as Antonio Kim Johnson (M/W 11/27/84) and Katie E. Petersen (F/W 12/15/84), walking southbound on the east sidewalk in front of 2040 S 68 St. I went to make contact with Antonio and Katie. I parked my squad angling the headlights at Antonio and Katie, activated my overhead emergency lights, and shinned my spot light at them. I exited my squad car and told Antonio and Katie to "Stop!"

Katie was carrying a purse with both hands in front of her with a black jacket draped over both of her hands and her purse. I was unable to see either of Katie's hands. I grabbed Katie's right elbow and wrist as I was going to place her arms behind her back and detain her. Upon grabbing Katie's right arm, I immediately noticed resistive tension in Katie's arm. PO Foy arrived on scene around this time.

Katie resisted my efforts to place her right arm behind her back, moving in a clockwise circle as I moved her arm from under her jacket to the small of her back. When I grabbed Katie's arm she immediately started yelling and screaming. As Katie moved in a circle she attempted to pull away from me. At this point I had grabbed my handcuffs and was attempting to place them on Katie's right wrist. When Katie jerked her body away from me, it caused my

ARRIVAL

providing any identification. I advised Ehrhardt if the sales clerk asked her for identification, she should not question the employee and immediately leave the business.

I provided Ehrhardt with \$40 from the WAPD Community Services Bureau fund for the attempted purchases.

Prior to beginning the compliance check I confirmed Ehrhardt did not have any identification on her person. The only item Ehrhardt brought with her during the compliance check was her cell phone. I took a photograph of Ehrhardt with a department issued digital camera, and I secured the photograph onto a WAPD media card to document Ehrhardt's appearance on the day of the compliance check. The media card was later secured in the Forensics and Technical Bureau.

After Ehrhardt exited the Mobil gas station with a pack of purchased Newport cigarettes, which cost \$7.80, I entered the business and made contact with the employee, Tariq. I advised Tariq he just sold a pack of cigarettes to a 17 year - old female. Tariq admitted he sold the pack of cigarettes, but he stated Ehrhardt told him her identification was inside her vehicle. Tariq said Ehrhardt was - supposed to go out to her vehicle after the sale was completed and come back with her identification so he could verify her age.

Bajwa also questioned me and asked how I knew she was not at least 18 years old if she did not have any it identification.
