TAVERN RELATED INCIDENTS NOT REQUIRING INCIDENT REPORT:

Disorderly Conduct: PO ISKANDARANI REPORTS:

On 12/04/2018 at approx. 2224hrs, officers responded to investigate a trouble call near S 84th St / W Walker St. Upon arrival it was determined to be an unknown problem at the new tavern called "El Sagitario" located at 907 S 84th St . Upon arrival, contact was made with Lindsey Shanklin F/W who was crying on the floor in the bar. She would not say what was wrong or what happened. I spoke with the bartender Viridiana P Hernandez F /H who advised of no problems in the bar. Patrons stated Lindsey fell over and was crying for an unknown reason. They stated she was special needs and she was not of age to be in the tavern. I made contact with the tavern owner Pascual Ramos M/H who was advised of the issue and asked that Lindsey was removed from the business and to be permanently banned. Lindsey's mother Sueann C Shanklin F/W arrived and removed her daughter without incident. Based on the nature of the incident I will be completing a tavern violation report.

Trouble Call: Officer Poklasny reports...

On 12/05/18 at 2129 hours, officers responded to the Bug N Out tavern located at 5630 W Lincoln Ave for a trouble call. The bartender, Alyssa L Pumphrey, F/B, called police after two male parties were involved in a physical altercation inside the tavern. I spoke with Aaron R Thompson (M/W) who witnessed a male later identified as Santos V Burdohan (M/W) instigated an altercation with another male only known as "Adam" after both were inside the tavern. Santos was visibly intoxicated and began to yell at Adam. Santos pushed Adam as he was trying to back away. Both parties then struggled with each other resulting in Santos being punched in the face. Santos had a minor scrape on his face and was bleeding, however denied any medical attention. The other party left prior to police arrival and was not located. Staff at the bar did not want anything done about the incident and only wanted Santos removed from the tavern. Santos was escorted outside and left the property without incident. There were no other problems and a tavern form was completed in the Q/A tab.

Endanger Safety By Use of Dangerous Weapon: Officer Vanden Boogard reports.... *E.S.B.U. O.D.W - armed while intox. & E.S.B.U.O.D.W. - pointing and aiming*

On 12/27 /18 at approximately 0217hrs, Officers responded to the 21 00blk of S. 95 St. for reports of shots fired. Investigation revealed Martin A. Resendez, M/H, was the passenger of a vehicle parked in front of heartbreakers when he racked the slide of his firearm and pointed it at two victims. The victim's ran away, however minutes later they observed the vehicle driving down the 9400blk of W. Becher St, when one of the victim's observed Resendez discharging the firearm up into the air. Resendez and the driver of the vehicle, Juan M. San Miguel, M/H were located driving in West Milwaukee and taken into custody. Resendez showed signs of impairment, performed poorly on SFST's, and refused to provide a breath sample. A warrant was obtained and a blood draw was completed. Resendez was booked for ESBDOUOW armed while intoxicated and pointing and aiming and he posted bail and was released. DA review is set for 12/28/18 at 0830hrs.
