RESOLUTION R-2026-5076**

**RESOLUTION TO AMEND AN EXISTING CONTRACT WITH R.A. SMITH, INC.  
FOR FEDERAL FUNDING WAGE COMPLIANCE REPORTING SERVICES  
RELATED TO THE CONSTRUCTION OVERSIGHT OF THE 2026 PRIVATE SIDE  
LEAD WATER SERVICE LATERAL PROJECTS FOR AN AMOUNT NOT TO  
EXCEED \$47,250**

**WHEREAS**, the City has an existing agreement with R.A. Smith, Inc. to oversee the construction of the City's 2026 private side lead water service lateral projects; and,

**WHEREAS**, the City uses Safe Drinking Water Loan funds for said projects which requires wage determinations and reporting per the Davis-Bacon Act; and,

**WHEREAS**, the City Engineering Department does not have staff who are trained in the reporting requirements; and,

**WHEREAS**, the City Engineering Department will need assistance in complying with all the reporting requirements; and,

**WHEREAS**, the Common Council deems it to be in the best interest of the City of West Allis that the proposal of R.A. Smith, Inc. be accepted; and,

**WHEREAS**, the funds to be used for this project have been included in the 2026 adopted budget.

**NOW THEREFORE**, be it resolved by the Common Council of the City of West Allis that the proposal dated June 11, 2026, submitted by R.A. Smith, Inc. for furnishing federal funding wage rate compliance services related to private side lead water service lateral projects not to exceed \$47,250 is accepted.

**BE IT FURTHER RESOLVED** that funding for this work has been budgeted and is available in the 2026 Capital Project Fund, and the services will be charged to DNR007 and MMSD11.

**BE IT FURTHER RESOLVED** that the City Engineer is authorized to amend the contract with R.A. Smith, Inc.

**BE IT FURTHER RESOLVED** that the city attorney is authorized to make any non-substantive changes to the approved documents to effectuate their intent and to prepare and deliver any other documents necessary to complete the approved transaction.
