An Ordinance to Establish Parking Restrictions on the North Side of the West 65 Feet of the 8900 Block of W. Grant St.

The Common Council of the City of West Allis do ordain as follows:

PART I. Pursuant to Section 10.10 of the Revised Municipal Code, the following parking restriction is established:

Street: W. Grant St.

Block: The West 65 Feet of the 8900 Block

Side: North

Restriction: 2 Hour Parking 8:00 AM to 6:00 PM, Monday - Friday

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.


