SUMMARY

NARRATIVE

Ptm. Steffen reports...

INITIAL CALL

On 11/02/13 at approx. 2053 hours, Officer Clark and I were clearing a call in the 2200 block of S. 62 St. Officers heard yelling from a block away and observed there was a verbal altercation in the beer garden of Johnny Hammer's, 6300 W. Lincoln Ave. Investigation revealed the verbal altercation involved the bartender, Amanda M. Altamore, F/W, 03/01/85 and customer Jennifer L. White, F/W, 11/27/72. Both parties wanted nothing done with this and were advised to keep the noise at a reasonable level. (See Call #13.049212).

CONTACT/AMANDA M. ALTAMORE/BARTENDER

I spoke with Altamore, who was identified by WI DL. After the investigation, I asked her who was watching over the bar, to which she stated she did not know. I asked to see her bartender's license, which she stated was inside the bar. Once inside, I observed a cook had been serving drinks while Altamore was outside.

Altamore showed me her West Allis bartender's license, which was valid from 07/01/11-06/30/13. I asked her if she had a valid license and pointed out that it was expired. Altamore advised me that she forgot to have her license renewed since she had a child.

I asked her if she had anyone at the tavern with a valid license which she stated she did not. I asked her to call someone with a valid bartender's license, which she called a party on the phone. Altamore advised that the person was "just around the corner" and should be at the tavern in a few minutes.

After 10 minutes, no one came to the tavern. I had Altamore call the party back to see how long it would be. She contacted the person and advised they have not left their residence yet. At 2116 hours, after no one came to the tavern with a valid bartender license, Johnny Hammers was closed until a licensed bartender arrived.

ARREST DECISION

Due to Altamore serving alcohol without a valid bartender's license and no one on scene with a valid bartender's license, she was mailed municipal citation M101749 for operating a license premises without a licensed person present.

Johnny Hammers does have a valid Class B beer and liquor license, with agent Jon R. Cervantes. Cervantes was mailed municipal citation M101748 for allowing an unlicensed person to operate a licensed premises without a licensed person on the premises.

CASE DISPOSITION

Both Altamore and Cervantes were given municipal court date of 12/16/13 at 0830 hours. A tavern report was completed for this incident.
