**RESOLUTION TO APPROVE BID OF UPI CONSTRUCTION LLC FOR SANITARY  
AND STORM SEWER RELAYS IN W. BURNHAM ST. FROM S. 69TH ST. TO S. 68TH  
ST. AND S. 68TH ST. FROM W. BURNHAM ST. TO W. MITCHELL ST. IN THE  
AMOUNT OF \$232,252.50**

**WHEREAS**, The Board of Public Works reports that it duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as hereinafter described; that the bids received as shown on the attached bid report were reasonable and hereby recommends and deems it to be for the best interests of the City of West Allis that the bid of UPI Construction LLC for 2024 Project No. 10 be accepted.

**NOW THEREFORE**, BE IT RESOLVED By the Common Council of the City of West Allis that the bid of UPI Construction LLC for 2024 Project No. 10 sanitary and storm sewer relays and pavement restoration in:

W. Burnham St. from S. 69th St. to S. 68th St.  
S. 68th St. from W. Burnham St. to W. Mitchell St.

(PLAN FILE NOS. S-1682, S-1683)

for the sum of Two Hundred, Thirty-Two Thousand, Two Hundred Fifty-two and 50/100 dollars (\$232,252.50) be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED That said improvements be installed with funding by Bond Funds, Sanitary Sewer Funds, Storm Water Management Fund.
