## STIPULATION

The License and Health Committee of the West Allis Common Council, by its representative the West Allis City Attorney's Office, special prosecutor Roger C. Pyzyk, and Palrena, Inc. by its attorney Andrew P. Arena, hereby agree and stipulate as follows:

- That the Summons and Complaint against Patrena, Inc. was filed with the City Clerk/Treasurer pursuant to section 125, 12(2), Wis. State.
- That the Summons and Complaint was served in accordance with section 125.12(2)(ar),
   Wis Stat.
- That Pairena, Inc., waives its right under section 125.12(2)(d), Wis. Stat., to appeal the proceedings had in this matter.
- 4. That in field of the above complaint being prosecuted, Kicks, located at 1900 S. 60<sup>th</sup> Street. West Allis, Wisconsin shall voluntarily close for business for a period of 10 consecutive days commencing 12:00 a.m., November 24, 2003 and terminating 11:59 p.m. December 3, 2003.
- 5. That the allegations which form the basis of this complaint shall not be used as grounds for any future suspension, revocation, or non-renewal proceeding, except to the extent that the facts alleged in the complaint demonstrate a pattern of conduct for Pairena, Inc.

- 8. That if the West Allis Common Council approves this stipulation, the City of West Allis and Palrena. Inc., are bound to the terms of the stipulation and failure to comply with said terms will result in continuation of the hearing procedures set forth in section 125,12(2)(b), Wis. Stat.
