Library Director's Report

-The interviews for the Children's Librarian position are ongoing.

- -The part-time Teen Librarian position remains open. The selected candidate accepted and rescinded. The position has been reposted.
- -The Library made the second payment on the elevator upgrade and the parts needed have been shipped. The installation is targeted for May.
- -National Library Week was 4/7-4/13 and staff and patrons participated in a spirit week. Patrons have been invited to design our new library card. Cathy Manthei, Library Board member, sent Library staff an Edible Arrangement to express thanks for their service.
- -The Library has started a seed library. Patrons may select up to 5 seed types and growing instructions are included. Seeds include kale, lettuce, carrots, flowers, and herbs.
- -The Library has been selected to join a partnership with the Wisconsin Badgers to promote literacy and summer reading. Stickers and posters will be distributed and raffles for books and Badger gear will be part of the program.
- -On Saturday, 4/27 the Friends of the West Allis Public Library general meeting will take place. The Milwaukee County Zoo will be presenting on conservation projects.
