**RESOLUTION ACCEPTING THE PROPOSAL OF VISUAL IMPACT LIGHTING  
FOR FURNISHING AND DELIVERING LUMINAIRES WITH SHORTING CAPS  
FOR A TOTAL OF \$70,930**

**WHEREAS**, the Inventory Division received proposals through a competitive bid process for furnishing and delivering electrical supplies for the Street Light Conversion Project for the Department of Public Works of the City of West Allis, and the proposals were reasonable; and,

**WHEREAS**, it is in the best interest of the City of West Allis that the proposal submitted by Visual Impact Lighting for furnishing 410 luminaires supplied with shorting caps for \$70,930 be accepted.

**NOW THEREFORE**, be it resolved by the Mayor and Common Council of the City of West Allis that the proposal submitted by Visual Impact Lighting, budgeted for 2026 Project # M26320M (Street Light Conversion Project), with funding provided by Account Number 354-6051-517-3102 (Capital Projects Fund, Project Activities, Other), is accepted.




