

**CITY OF WEST ALLIS
RESOLUTION R-2024-0090**

**RESOLUTION TO APPROVE THE BID OF BSI (BUILDING SERVICES INC.) FOR
RENOVATION WORK AT THE WEST ALLIS HEALTH DEPARTMENT**

WHEREAS, the West Allis Health Department received ARPA COVID Recovery funding from the State of Wisconsin Department of Health Services;

WHEREAS, the Health Department worked with Purchasing staff to obtain a bid for renovation work related to removal of an existing wall and installation of a retractable wall between conference rooms at the Health Department to better accommodate large gatherings and potential emergency operation's needs;

WHEREAS, the proposal submitted by BSI (Building Services Inc.) through the use of a GSA governmental cooperative contract is in the amount of \$56,725.00; and

WHEREAS, the Health Department has received approval from the Wisconsin Department of Health Services to expend these funds for this project as an allowable use of ARPA COVID funds; and

WHEREAS, the 2024 adopted budget included an appropriation of ARPA COVID Recovery funds for the implementation of this project.

NOW THEREFORE, BE IT RESOLVED that the Common Council of the City of West Allis:

1. Authorizes the Health Department to accept the proposal from BSI for building renovations, not to exceed \$56,725 in funding from ARPA COVID Recovery grant funds (Account 240-7938-542.70-01, Project EF2106), and
2. That the Health Commissioner is hereby authorized and directed to take all other actions deemed necessary to complete this project.
