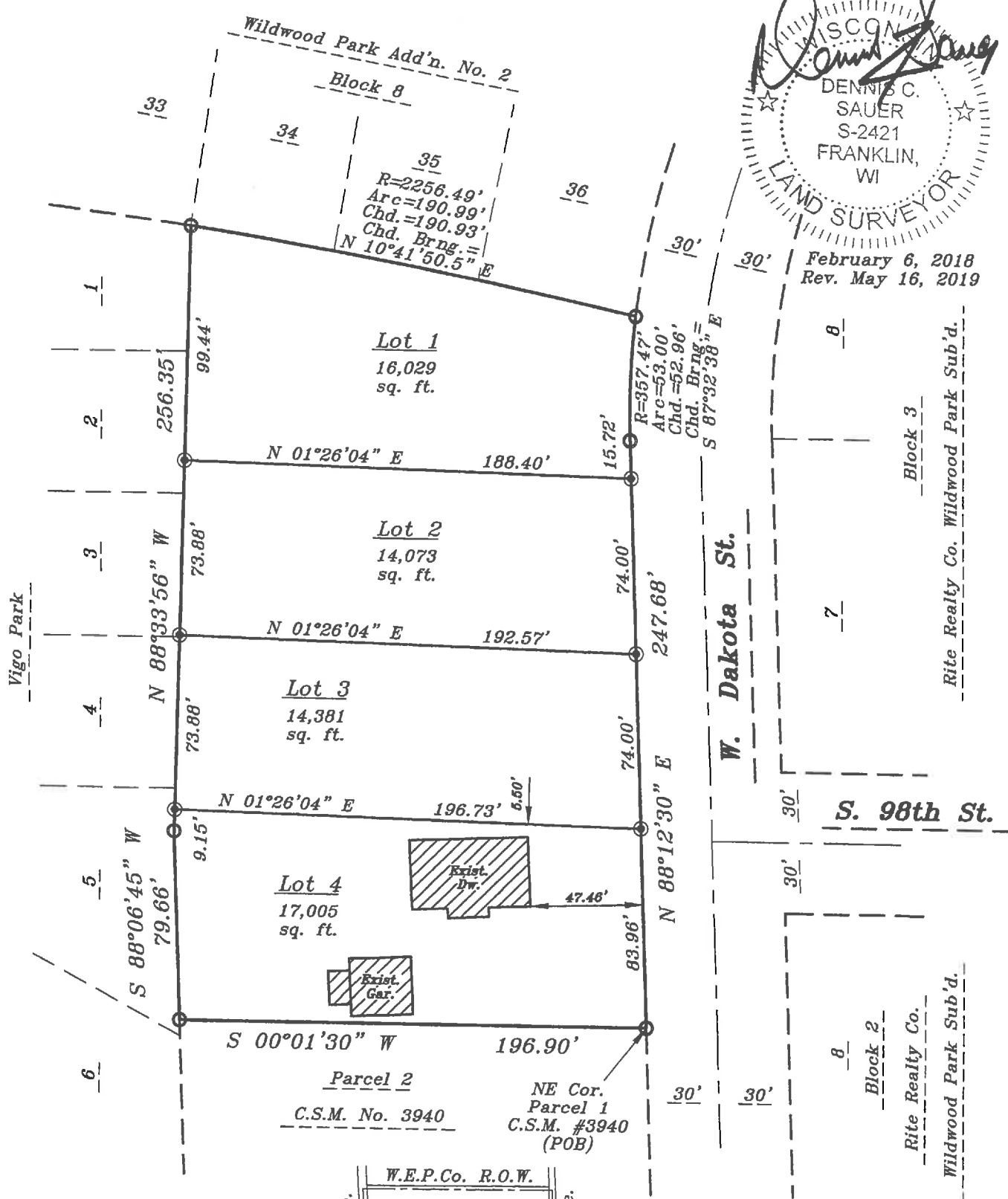


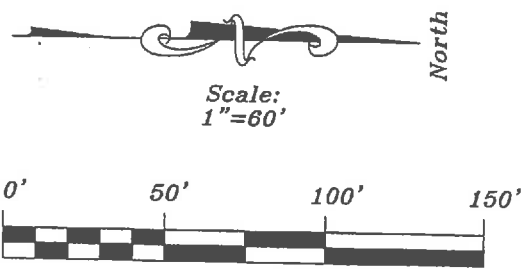

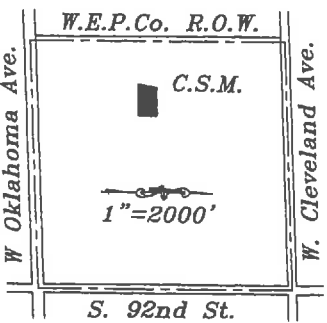

That I have surveyed, divided and mapped a re-division of Parcel 1 of Certified Survey Map No. 3940, being a part of the Southwest 1/4 of the Southeast 1/4 of Section 8, Township 7 North, Range 21 East, in the City of West Allis, Milwaukee County, Wisconsin, bounded and described as follows: Beginning at the Northeast corner of Parcel 1 of said Certified Survey Map No. 3940; thence S 00° 01' 30" W along the East line of said Parcel 1; 196.90 feet, to the Southeast corner of said Parcel 1; thence S 88° 06' 45" W along the South line of said Parcel 1, 79.66 feet to a point; thence N 88° 33' 56" W along said South line, 256.35 feet to the Southwest corner of said Parcel 1; thence Northerly along the West line of said Parcel 1, 190.99 feet along the arc of a curve whose center is to the East, whose radius is 2256.49 feet, and whose chord bears N 10° 41' 50.5" E, 190.93 feet to a point on the South line of West Dakota Street; thence Easterly along the South line of said West Dakota Street 53.00 feet along the arc of a curve whose center is to the North, whose radius is 357.47 feet, and whose chord bears S 87° 32' 38" E, 52.96 feet to a point; thence N 88° 12' 30" E along said South line, 247.68 feet to the point of beginning said lands containing 61,488 square feet (1.41 AC.)

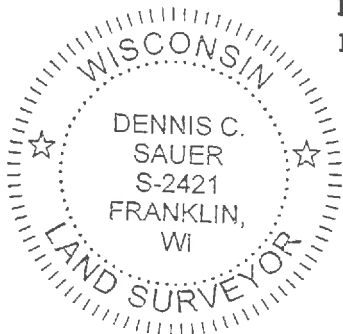
