Alderman Czaplewski received and dropped off the attached petition. The petition requests that Livingston Terrace at Becher/67th be changed to a one-way going outbound.

There are no traffic engineering reasons for this change. There are no unusual sight problems in this area. In fact, having a curved street is a form of traffic calming.

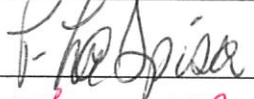
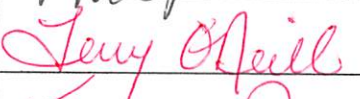
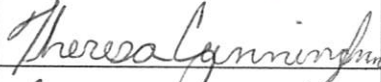
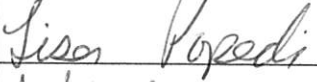
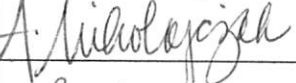
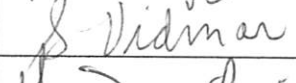
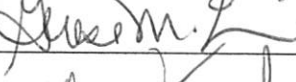
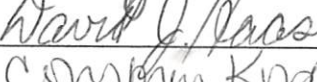
This change will impact and increase traffic on the adjacent streets and impact the Second Aldermanic District along 68th Street too. There is only one signature from a resident on 67th Place. We believe 67th Place and Grant Street would be impacted the greatest by this change.

There are also issues of cost for the temporary trial (this couldn't be done by simple barricades) and additional cost if made permanent. As I have mentioned previously, I don't believe traffic engineering should be done by petition.

Petition to Modify Livingston Terrace

Petition summary and background	This Petition has been started to modify the street of Livingston Terrace. The reason pertains to the line of sight issue when it comes to vehicles coming directly off Becher or 67 th Street. The said vehicles do not have sufficient time to stop at legal speeds once visual confirmation has been made with pedestrians. The modification will stop incoming traffic from Becher & 67 th Street, but will not stop outgoing traffic. This should drop the percentage of risk to this area with concern to pedestrians and their safety.
Action petitioned for	Closure of traffic off Becher & 67 th onto Livingston Terrace and Revere Place with the use of Barricades and Signage. (See attached Drawing for visual.) Permanent once street is re-surfaced.
