An Ordinance to repeal Salary Ordinance No. O-2013-0006 and re-establish the salaries of certain Miscellaneous Employees of the City of West Allis for 2013-2014.

The Common Council for the City of West Allis do ordain as follows:

PART I. Salary Ordinance No. O-2013-0006 is hereby repealed.

PART II. The wage and salary ranges of the following miscellaneous employees commencing January 1, 2013 shall be as follows:

Jan. 1, 2013 - Dec. 31, 2014 (1)

Part-Time Custodian: \$10.00 - \$13.00/Hr.

Provisional Laborers: \$8.00 - \$10.00/Hr.

Seasonal Laborers - 1st Year: \$7.50 - \$8.50/Hr.

- 2nd Year: \$8.00 - \$9.00/Hr.

- 3rd Year: \$8.50 - \$9.50/Hr.

- 4th Year: \$9.00 - \$10.00/Hr.

Library Page: \$7.50 - \$8.50/Hr.

Lead Library Page: \$8.50 - \$9.50/Hr.

Election Inspectors: \$100.00/Day (2)


(1) The above pay rates represent resident (R) rates. These resident pay rates shall be reduced by 2% for perimeter status employees.

(2) Shall receive \$5.00 additional for attending instructional meeting prior to each primary and regular election; the Chief Election Inspector shall receive an additional \$30.00 and the Assistant Chief Election Inspector shall receive an additional \$15.00 for service at each primary and regular election.


PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.


