**ORDINANCE TO AMEND THE CITY OF WEST ALLIS SALARY SCHEDULE DUE
THE 2020 ADOPTED BUDGET ACTION**

Each of the salary grades of non-represented employees are increased by 1.5% and an additional .5% for West Allis residents.
