#### THE WEST ALLIS COMMON COUNCIL TO SHELLY M. BEASTER:

You are hereby notified that a sworn complaint, a copy of which is attached, has been duly made and filed, requesting a hearing on the suspension, revocation or non-renewal of your Class I Operator's License (Bartender's License), pursuant to the provisions of sec. 125.12, Wis. Stats.

NOW THEREFORE, you, Shelly M. Beaster, are hereby summoned to appear before the License and Health Committee of the West Allis Common Council in Room 128 of the West Allis City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, on September 25, 2007, at 6:00 p.m., or as soon thereafter as this matter can be heard, to admit or deny the allegations in the complaint. You may be represented by counsel on this date.

In the case of your failure to appear as required by this summons, the allegations in the complaint against you shall be taken as true and, if the License and Health Committee of the West Allis Common Council finds the allegations sufficient, a recommendation that your license

be suspended, revoked, or not renewed will be made to the full Common Council. The Common Council may then vote to suspend, revoke, or not renew your license.

You are further notified that if you appear as required by this summons and contest the allegations in the complaint, a hearing will be scheduled at a later date before the License and Health Committee, at which time you may be represented by counsel, cross examine the witnesses who testify adversely against you, and present witnesses in your own behalf. A written transcript of said hearing shall be made and you may obtain a copy of the transcript of this proceeding at your expense.

Kurt E. Kopplin, being duly sworn, on oath deposes and states as a complaint against Shelly M. Beaster as follows:

- 1. That the complainant is a resident of the City of West Allis, is the duly elected Alderperson for the Second Aldermanic District in the City of West Allis, and makes this complaint at the direction of the License and Health Committee of the West Allis Common Council.
- 2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis and the West Allis Police Department, which records complainant believes to be reliable and accurate.
- 3. That Shelly M. Beaster is the holder of a Operator's License No. 07-315 granted on July 5, 2005 which expired on June 30, 2007, entitling Shelly M. Beaster to work as an operator upon premises licensed under retail Class "A" or Class "B" Intoxicating Liquor and/or Fermented Malt Beverage licenses pursuant to section 9.02(16) of the West Allis Revised Municipal Code and sections 125.17, 125.32(2) and 125.68(2) of the Wisconsin Statutes.
- 4. That on June 1, 2007, Shelly M. Beaster filed an application for an Operator's License entitling Shelly M. Beaster to work as an operator upon premises licensed

under retail Class "A" or Class "B" Intoxicating Liquor and/or Fermented Malt Beverage licenses pursuant to section 9.02(16) of the West Allis Revised Municipal Code and sections 125.17, 125.32(2), and 125.68(2) of the Wisconsin Statutes.

- That on June 27, 2005 and December 23, 2005, Shelly M. Beaster operated a 5. motor vehicle while under the influence of an intoxicant, contrary to section 346.63(1)(A), Wis. Stats., and was subsequently convicted of said offenses.
- 6. That on December 23, 2005, Shelly M. Beaster also failed to report an accident contrary to section 346.70, Wis. Stats. and was subsequently convicted of said offense.
- 7. That the conduct of Shelly M. Beaster described in paragraphs Five and Six substantially relates to the alcohol beverage licensed activity contrary to 125.04(5)(b), so as to disqualify Shelly M. Beaster from obtaining, keeping, or renewing an Operator's License.

WHEREFORE, Kurt E. Kopplin requests that Shelly M. Beaster be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Operator's License issued to Shelly M. Beaster should be suspended, revoked, or not renewed.
