

**CITY OF WEST ALLIS
RESOLUTION R-2024-0026**

**RESOLUTION AUTHORIZING THE HEALTH DEPARTMENT TO ACCEPT AND
EXPEND FUNDING FROM THE CDC EXPLORER PROGRAM FOR THE
NATIONAL ENVIRONMENTAL ASSESSMENT REPORTING SYSTEM (NEARS)**

WHEREAS, the Centers for Disease Control and Prevention (CDC) will provide 2024 NEARS Explorer Program funding to the West Allis Health Department to support tracking of environmental assessments conducted as a result of foodborne illness investigations.

WHEREAS, the West Allis Health Department has applied to the CDC NEARS Explorer Program for grant funding from February 1, 2024 to December 31, 2024.

WHEREAS, the West Allis Health Department serves as the agency responsible for administering these funds;

WHEREAS, the West Allis Health Department has been awarded \$2,500 in CDC Nears Explorer Program grant funding to support the Health Department's focus on exploring the implementation of CDC NEARS; and,

WHEREAS, the 2024 budget did not include an appropriation for the CDC NEARS Explorer Program grant funding.

NOW THEREFORE, BE IT RESOLVED that the Common Council of the City of West Allis:

1. Authorizes the West Allis Health Department to accept CDC NEARS Explorer Program grant funding and
2. Appropriates and amends the 2024 City Budget to allow for the expenditure of CDC NEARS Explorer Program grant funding as allowed in the grant program; and
3. That the Health Commissioner is hereby authorized and directed to take any and all other actions deemed necessary to effectuate the intent of this Resolution.
