Based on providing supplemental drawings for abbreviated permitting requirements, **CORRE** is submitting the following amendment proposal to you:

- Detailed survey of the project site to include:
 - o Wetland delineation
 - o Ordinary and high water levels
 - o Detailed survey of the culvert
 - o Topography surrounding the culvert for 100' in all directions
 - o Stream bed topography
 - o Miscellaneous structure and utility identification within the immediate area
 - o Roadway edges
- Coordination with WisDNR for permitting
- Supplemental detailing on project plans to conform with permit requirements

CORRE'S lump sum fee (not to exceed) for the work as noted above under Amendment #1 is to provide the above noted deliverables within the schedule shown is **\$1,810**.


