The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of January.

#### **Incident reports:**

# Case #15-54749, 12/15/2015, 2247 hrs: 1101 S 61 St – Papa's Pub (late reporting)

On 12/15/2015, Officers responded to Papa's Pub for a trouble call involving a patron assaulting the bar owner and then creating a disturbance outside of the bar. While en route, WAPD Dispatch received a separate call from residents nearby that a white male was beaten by two unknown males in the middle of the street and was unconscious. The Offenders fled on foot. It was later determined, the unconscious victim, was the party causing the trouble inside the tavern. The party who later assaulted him in the street was issued a Municipal Citation for Disorderly Conduct. The unconscious party was taken to Froedtert Hospital for treatment.

## Case #16-3355, 01/27/2016, 1635 hrs: 1503 S 81 St – Captain Nicks

On 01/27/2016, Officers were dispatched to Captain Nicks for a report of a car collision and an argument. The Offender was intoxicated and struck another vehicle in the parking lot. He was arrested for his 4<sup>th</sup> Offense OWI. He refused Stand Field Sobriety Tests and Implied Consent Chemical Testing; a search warrant was obtained and his blood was drawn. He was unable to post bail and was transported to the County Justice Facility. Video from the tavern reveals that within a 3 ½ hour period, the Offender was served one bottle of beer and six mini pitchers.

## Tobacco and Alcohol Compliance checks:

#### Case #15-56672

On 12/30/2015, the West Allis Police Department conducted 12 tavern checks at randomly selected West Allis taverns that have a license to serve alcoholic beverages. The check was completed through the use of a 20 year old male who entered each tavern and attempted to purchase a beer without providing identification. Out of the 12 businesses, eight asked for identification and would not provide the beverage without it. Employees and license holders from the four businesses that did not require identification were issued citations through the mail. Both the employees and license holders were notified about the violation. The following businesses were in violation:
