Before receiving a permit as required in this Chapter, the owner or agent for the owner shall pay a fee as specified hereafter. Fees shall be assessed in accordance with the provisions of this section. For the purposes of this fee schedule, "Residential" shall mean one- and two-family dwellings and their accessory structures only, and "Commercial" shall mean all other types of construction, including multi-family buildings of three or more units, and their accessory structures.

(1) Minimum Fees and Calculations

(a) Minimum Permit Fee

- 1. Residential; unless otherwise stated in this fee schedule..... \$60.00
- 2. Commercial; unless otherwise stated in this fee schedule..... \$100.00

(b) Fees are determined by using the Construction Value or the Area Calculation, whichever is applicable. Fees may also be determined by averaging a fee found by the Area Calculation and the fee found by the Construction Value when deemed appropriate by the Plan Reviewer or Building Inspector.

(c) All fees in this fee schedule shall be rounded up to nearest full dollar amount.

(d) Fees may be waived or modified for City owned properties or when work is performed by City employees.

(e) The Director may waive, modify or alter any permit fee as deemed appropriate to reflect actual scope of work and impact on the Department.
