



INITIAL CALL

On 11/01/14 at approximately 0153 hrs., officers responded to GR's pub located at 6827 W. National Ave. for a report of a theft of a purse.

CONTACT WITH KARA M. JONES

Upon arrival, I made contact with the victim, Kara M. Jones, F/W, 08/27/81, who stated she and a group of friends arrived at GR's pub at approximately 2230 hrs. Jones observed a M/W and F/W she believes stole her purse, playing darts and pool. The suspects made casual conversation with Jones and her friends.

Jones placed her purse on a chair next to the bar near the pool table. Jones also placed her jacket over her purse in an attempt to conceal her purse. Jones stated she never let her purse and jacket out of her sight.

At some point the suspects left the bar for a short amount of time and then returned. Jones overheard the suspects state that they went home to "get high".

At approximately 0200 hrs., Jones grabbed her coat from the bar chair and realized her purse had been taken. At this point Jones observed the suspects had also left the bar. Jones stated she believed she overheard the suspects state they lived on S. 71 St. and W. Orchard St.

Jones stated she could identify the suspects.

LACK OF CONSENT

Jones did not give anyone permission to take her purse containing several items causing her a financial loss.

DESCRIPTION OF SUSPECTS

F/W approximately 5'6" skinny build. Sores/Pockmarks on her face. Brown hair. Early to mid 30's.

SURVEILLANCE VIDEO

On 11/04/14, I picked up the surveillance video from GR's pub. I was able to open the video and the images were slightly blurry and grainy. I was able to observe the following:

At 0108 hrs., the female suspect is by the pool table bent down. The female suspect looks under the pool table and then looks towards where Jones' purse was located.

At 0110 hrs., the female suspect bends down by Jones' purse, appears to grab it and then walks away towards the east side of the bar.

At 0112 hrs., the female suspect returns to the west side of the bar.

At 0114 hrs., the female suspect again leaves.

At 0123 hrs., the male suspect then leaves the bar.

CASE DISPOSITION

STATEMENT BY ROBERTO M. QUIRINO-CONTACT

On scene, I spoke with Roberto M. Quirino, (m/w, 10/16/88), who stated he did not see the theft take place, but was able to describe what the offenders looked like.

Roberto described the Hispanic male in his mid 20's as approx. 6'00, 165lbs, thin build, short hair wearing a black hat, black hoodie without writing, jeans and black and gray Nike shoes. He heard him making reference to living in the area of 71st and Orchard St.

The white female had a lot of acne on her face and was approx. 5'6-5'8, 120lbs, long blonde hair in a "bun", possibly in her 30's wearing a gray hoodie with jeans and white Nike shoes.

CANVAS

I conducted a canvas of the area traveling up National Ave. to 70th St. and through the east/west alley just north of W. National Ave. I traveled north through the alley to Orchard St. where I then went west to 71st St. which I then took south to W. National Ave. I did not notice the victim's purse anywhere in the area.
