**SUMMARY**  
  
Belli reports : Battery : 7930 W. National Ave. : Jock Stop : Christopher J. Bitz reported an unknown black male assaulted him the previous evening as he was about to close the bar. The offender punched him in the head, scratched his face, and threw him onto the stairs of the front of the bar causing abrasions to his legs and possibly a sprained or broken toe. Bitz is not sure he wants to pursue any charges. The offender is described as a black male in his early 30s, with short black hair, six foot one inches tall, about 210 lbs., and last seen wearing a polo shirt and shorts.

**NARRATIVE**

**INITIAL RESPONSE**

I responded to the Jock Stop for a report of an assault.

**STATEMENT OF VICTIM--CHRISTOPHER BITZ**

I spoke to bar owner Christopher Bitz inside of the Jock Stop. He said for the past few months, a black male has walked into the bar on several occasions and asked patrons for money and cigarettes. Bitz said he hasn't reported these incidents to police and the man usually leaves without incident.

The previous day Bitz was in the bar with one patron by the name of Eric Block. Bitz was getting ready to close down for the evening because there were no other patrons. Bitz said the same black male entered the bar and asked for money. Bitz told him to stop coming into the bar and asking for money and told him to leave. When the man remained standing near the front entrance door, Bitz said he walked toward the man. The offender told Bitz not to touch him. Bitz reached past the man and held the front door open.

As the offender walked out of the door, he reached back and punched Bitz on the left side of his head, leaving a bump and bruise, and grabbed at Bitz, leaving scratches on his face. The man grabbed Bitz' shirt, leaving scratches on his chest. The offender dragged Bitz down a short flight of stairs that lead to the front door. Bitz ended up on the sidewalk in front of the bar. The offender called Bitz a "nigger."

Eric Block pulled the offender off of Bitz and the offender walked away northbound on S. 80 St.

Bitz said he thought one of his toes was either sprained or broken, because it was swollen, but he hadn't sought medical treatment yet.

Bitz said he did not want to pursue prosecution. I told him I would leave the report open until Monday, November 3, 2104, and if he changed his mind he could call me or send an e-mail message to me. I provided my business card.

**LACK OF CONSENT**

Christopher Bitz did not give permission to anyone to punch him, scratch him, and drag him down some stairs, causing minor injuries.
