An Ordinance to establish the salary of the Mayor of the City of West Allis for the four year term of April 17, 2012 through April 18, 2016.

The Common Council for the City of West Allis do ordain as follows:

PART I. The wage and salary range of the Mayor of the City of West Allis, elected on or after April 1, 2012, for the four year term of April 17, 2012 through April 18, 2016, shall be as follows:

April 17, 2012 through April 15, 2013-\$63,000April 16, 2013 through April 14, 2014-\$64,000April 15, 2014 through April 20, 2015-\$65,000April 21, 2015 through April 18, 2016-\$66,000

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect April 17, 2012, and be in force from and after its passage and publication.


