RESOLUTION R-2026-5061**

**RESOLUTION AUTHORIZING THE SUBMITTAL OF AN APPLICATION TO THE
DEPARTMENT OF NATURAL RESOURCES FOR PRINCIPAL FORGIVEN
FINANCIAL ASSISTANCE AGREEMENTS IN AN AMOUNT UP TO \$3,800,000 TO
UNDERTAKE PROJECTS TO REPLACE PRIVATE LEAD WATER SERVICE
LINES**

WHEREAS, the City of West Allis ("the City") wishes to undertake a project to replace private lead service lines at residences, pre K-12 schools, and licensed day care centers, identified as DNR Project No. 5404-17; and,

WHEREAS, the City has submitted an Intent to Apply for funding to the Safe Drinking Water Loan Program (the "SDWLP") for financial assistance in the form of a loan made by the SDWLP to the City of which a portion of the principal will be forgiven at the time that loan disbursements are made to the City, pursuant to the DNR Financial Assistant Agreement arising out of the applications; and,

WHEREAS, the City intends to reimburse municipal accounts with financial assistance proceeds of the SDWLP loan; and,

WHEREAS, the SDWLP has, in the past, identified that the City is eligible for partial reimbursement of a SDWLP loan.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the Mayor, City Clerk, and City Engineer are authorized to execute the application for the principal forgiven financial assistance program of the SDWLP.

BE IT FURTHER RESOLVED that, to fund the Lead Water Service Replacement Program, the City is applying to the Safe Drinking Water Loan Program (SDWLP) for financial assistance, which will be a combination of forgivable and non-forgivable loan funds, and any principal not forgiven will be covered by special assessments or repaid through the City's general tax levy, unless other funding becomes available.

BE IT FURTHER RESOLVED that the City Engineer is authorized to make any non-substantive changes to the approved documents to effectuate their intent and to prepare and deliver any other documents necessary to complete the approved transaction.
