Dear Ms. Bell:

This notice is being provided pursuant to the Worker Adjustment and Retraining Notification Act of 1988, which requires employers to give official notice to certain government units of officials of a pending facility shutdown.

As previously announced, a new licensing agreement will move production and distribution of Crestwood goods to an outside company. SUPERVALU will shutdown the Crestwood facility located at 1710 South 108<sup>th</sup> Street on January 29, 2005. The closing will affect 51 employees during the final phase of shutdown. All positions at the facility will be eliminated. This closure is permanent.

A list of the affected positions and number of employees holding those positions is attached. Affected employees will not have bumping rights at SUPERVALU or with the new owner.

The Bakery Workers Local 205 represents some of the affected employees. The chief elected official of this union is John Blackburn. His address is 8626A West Greenfield Avenue, West Allis, WI 53214. Some employees are represented by the Teamsters "General" Local Union 200. Their chief elected official is Darryl Connell. His address is 6200 West Bluemond Road, Milwaukee, WI, 53213.
